Tax Receipt CRA Rules:

As a registered charitable organization in Canada, Wounded Warriors Canada is able to provide tax receipts for Monetary Donations as well as Gifts in Kind. A Gift in Kind is defined as a kind of charitable giving in which, instead of money to buy needed goods, the goods themselves are provided.

To be eligible for a tax receipt for a Gift in Kind, a business or person must perform the following actions:

- 1. Provide to Wounded Warriors Canada an invoice or receipt, on company letterhead (if applicable) representing the full value of the item being provided
- 2. Full Mailing Address where the tax receipt is to be sent must be provided. If tax receipt is to be sent electronically, an email address must be provided.

Please Note: A tax receipt will not be issued prior to the conclusion of the event and until Wounded Warriors Canada receives the funds from the event. We are unable to process tax receipts until such time we have received the funds for deposit. Wounded Warriors Canada works diligently to ensure, once the funds are received a tax receipt will be issued within 30 days.

IMPORTANT: As of 2015, the CRA no longer allows tax receipts for Gifts of Service (i.e. Lawn Care Services, Home Painting Services). As such Wounded Warriors Canada is unable to provide tax receipts for Gifts of Service.
