

Bull Falls Homebrew Club Petition for Club Bylaws Change
Submitted September 10th, 2020 via monthly meeting and club facebook page and club website.

I, Tim Oelke Petition to amend the Bull Falls Homebrew Club Bylaws,
Article IX-Finances, section 4;

Adding the officers discretionary fund of \$300 per fiscal year if funds are available to the club. Of which no individual purchase greater than \$150 may be made without club approval as outlined under Article IV-Voting. Discretionary funds are to be agreed upon annually as part of the annual club budget and is subject to change pending club approval. Any and all purchases under this discretionary fund shall be used exclusively for club purposes and no officer shall personally benefit from these or any club funds.

I, Tim Oelke Petition to amend the Bull Falls Homebrew Club Bylaws,
Article VI-Meetings, Section 1-Regular Monthly Meetings;

to include "each meeting shall also involve an educational session related to fermented beverages or homebrewing" to comply with the future Charitable Organization Incorporating laws and rules (Pending)

I, Tim Oelke Petition to amend the Bull Falls Homebrew Club Bylaws,
Article III-Membership, Section 7;

to change the membership renewal deadline from February 1st, to the March monthly meeting Meeting, which is the 2nd thursday of the month. Renewal period will open December 1st and any members who renew will continue their membership into the following year. New members who join after December 1st will be regular members immediately and through the following year.

And

"Remove all mentions of new members who join on or after October 1st receiving a discounted dues rate of 50%. Members who join or renew between the day after the March monthly meeting and December 1st will only be eligible for membership of that year. The club executive board may decide to waive these deadlines on a case by case basis by majority vote of current officers."

I, Tim Oelke Petition to amend the Bull Falls Homebrew Club Bylaws,
Article IX- Finances, section 4, to change;

"The annual budget of the Bull Falls Homebrew Club shall be presented by the Treasurer at the monthly meeting following elections and approved by a majority vote"

To

"The annual budget of the Bull Falls Homebrew Club shall be presented by the Treasurer at the March monthly meeting and approved by a majority vote".

I, Tim Oelke Petition to amend the Bull Falls Homebrew Club Bylaws,
Article III- Membership, to include section 10 - Club discount cards;

“ The Club Officers may determine each year to continue or discontinue the club discount card program each February, for the next fiscal year. Club discount cards shall be printed by an officer with assistance from any regular member in good standing for recruiting offers from businesses that have an emphasis, but not limited to, home brewing or craft beverages. Club discount cards are only valid for paid regular members in good standing with the club, not for spouse members or honorary members. Members must renew their membership before or at the March meeting deadline to be eligible for a new membership card. New members or members who renew after the deadline will only be eligible for the homebrew depot discount, if still available, and will not receive a membership card. All other normal membership benefits shall be available to new and renewing members, including but not limited to casting votes, attending club events, and access to other club benefits.”
