I am fully aware that horse sports, including driving, and The National Drive involve inherent dangerous risk of serious injury or death and by participating I do so voluntarily and expressly assume any and all risks of injury or loss, and I agree to release The National Drive, its officers, directors, employees and agents, and the Committee, from and against all claims including any injury or loss suffered during or in conjunction with The National Drive. I agree to indemnify and hold harmless The National Drive, the Committee, its officers, members and/or any officials of The National Drive, and property owners from any and all claims for injury or loss caused by me or my horse that occurs during or in conjunction with this event.
