Section 6-2-14 of Chapter 2: Utilities- Billing Charges, Solid Waste and Recycling Rates. Every utility account within the City of Worthington that is currently charged the residential refuse rate will be increased by \$2.00/month, and every utility account that is currently charged the commercial refuse rate will be increased by \$1.00/month. Seconded by Risser.

Motion by Tuel to Approve and Adopt 1<sup>st</sup> Reading of Ordinance No. 178... Additional parking specifications and distance requirements have been added to be in compliance with Iowa DOT rules in regards to the Highway 136 Improvements Project. Seconded by Risser. Roll call.
