City Council Minutes

January 2nd, 2017

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, and Dan Krueger were present and Ron Doll was absent.

Jim Poepping was sworn in as Mayor for a two year term; Pat Nathe and Dan Krueger were sworn in as Council members for a four year term.

On a motion by Dan Krueger, seconded by Shawn Duevel and carried the minutes from December 5th, 2016 were approved.

Fire Chief, Allen Fiedler was present to inform the Council on one medical call last month. ISO has completed its analysis of the structural fire suppression delivery system provided for New Munich. Effective April 1, 2017 the new Public Protection Classification will be 05/5X. Allen submitted a couple bills, USA Fire Safety \$692.00 (pump testing) and Membership dues \$40.00.
