Lessons In History - Review

We are most desirous of continuing our series of history lessons. There will be several more lessons in American history that the establishment history books don't cover and then we intend to discuss the revolutions of France, Germany, Russia, and others, in order to reveal the agenda of the World Revolutionary Movement (WRM). However, there are major incidents occurring right now all around us which will one day become known to historians as the culmination of Oswald Spengler's Decline of the West. These current incidents are of such monumental importance that we are compelled to report them. Please bear with us.

This issue of the Intelligence Newsletter will be using information that can be found in past history lessons. In a sense, this entire issue will be a gathering of many of those past lessons in history. We are now genuinely seeing the summit of the great battle between Jacob and Esau.

Most of us Christian Americans come from families who for many generations have understood that it was our Christian heritage, which made the United States great. It was not the concept of "this is a nation of law" that did it. It was because we thought, worked and fought as Christians. The key that made America great was not the Constitution. As long as those whom we elected to follow the Constitution did it in the name of Jesus Christ and with the Christian Bible, our nation was safe. The ACLU, ADL, WJC, AJC, B'nai-B'rith, Freemasonry, every Rabbi as well as all the other non-Christian organizations in the country can dispute this all they want but America became great because of Christianity.

But the United States is no longer a Christian country. We are now having to pay the price for that fact. Forget using the Constitution in a Christian sense, not only for your own defense nor to determine the lawfulness of your actions. Forget using the ballot box or the jury box to turn this nation back to Christ. That is a hard thing to say but it is true.

This issue will show you just how true that statement is. "And so it was, when Israel had sown, that the Midianites came up, and the Amalekites, and the children of the east, even they came up against them; And they encamped against them, and destroyed the increase of the earth, till thou come unto Gaza, and left no sustenance for Israel, neither sheep, nor ox, nor ass."

"For they came up with their cattle and their tents, and they came as grasshoppers for multitude; for both they and their camels were without number: and they entered into the land to destroy it. ADL Update

Once again, the raw political power of Political Zionism has been felt by us Americans. We have reported in past issues of the Intelligence Newsletter that the [Anti-Defamation League](#) of the [B'nai-B'rith](#) was being investigated for such unlawful activities as obtaining official confidential police records and distributing them, even to foreign governments. They were under investigation for their notorious agent provocateur program, again in cooperation with federal and state police organizations. They were also under investigation for their undue influence on government at all levels, to include providing seminars for police agencies advising who and what organizations should be under surveillance and even the preparation and presentation of "model" bills for legislative action.

The District Attorney of San Francisco mustered enough courage to bring about the investigation after it was discovered that one of their own police officers, Tom Gerard (also a former CIA agent), was working with an ADL undercover agent Roy Bullock. They were collecting information on selected individuals and organizations and selling that information to the South African government. The investigation led to an enormous network of similar undercover ADL operations throughout the world.

One of the more serious aspects of the ADL's unlawful and immoral activities is the Cult Awareness Network's participation in official law enforcement activities. The [Cult Awareness Network](#) (CAN) is a part of the ADL and the B'nai-B'rith. It was this organization that played the major part in the raids on the Branch Davidians at Waco and the Weaver family in Idaho. They provided the "Psychological Profiles" and the "de-programming and re-programming" for the government, which justified the final courses of action.

Well, the District Attorney of San Francisco cut a "deal" with the ADL! They settled by allowing the national Chairman Melvin Salberg and national Director Abraham H. Foxman of the ADL to state, "The agreement we have reached confirms our consistent position that ADL has engaged in no misconduct of any kind."

Now for another lesson in genuine Jewish Chutzpah! The agreement was to include the ADL spending up to \$50,000 in "reward" money to informants and agents provocateur to solve "hate crimes." This is not in addition to the approximately one million dollars they already spend on this activity but is simply included in it!

Also, to further emphasize the Chutzpah, they agreed to spend \$25,000 to train the prosecutors in the San Francisco District Attorney's office to teach schoolchildren about the evils of intolerance, violence and bigotry!

Victor Marchetti in his *New American View* has this to say: "The ADL's sweetheart deal with the San Francisco DA's office underscores the success of the Jewish organization's longtime program of penetrating U.S. law enforcement agencies-including the FBI and the Department of Justice. Virtually every major metropolitan police department and many in

smaller communities have been infiltrated by ADL agents-and in some instances, by the Israeli intelligence service. The FBI, too, has been contaminated, and the Justice Department's bureaucracy (not just the OSI) is riddled with activist pro-Israeli Jewish lawyers."

"This unhealthy relationship not only allows the ADL access to official classified information on individuals and groups, but also permits its agents to insert derogatory and even false data on the enemies, real and imagined, of this band of fanatics into police files. The perversion of America's law enforcement system by the ADL is more than an official embarrassment; it has made police departments across the nation vulnerable to an insidious form of political extortion by an organization whose first loyalty is to a foreign government." End of quotes. *New American View*, P.O. Box 999, Herndon, VA 22070.)

Perhaps the one good side to the agreement is that the San Francisco District Attorney will keep the records that the ADL collected on nearly 10,000 individuals and over 950 groups. The significance of this is that these individuals and groups, individually or collectively through class action suits, can still sue in civil court. One must weigh the validity of this course of action in light of the modern American Judicial Branch, as well as the Legislative Branch and Executive Branch of government. As we continue with this issue of the Intelligence Newsletter, this will become more apparent.

More Zionist Power

From the *New American View*, Dec. 1, 1993 issue, we find another example of raw Zionist power in the current United States. Keep in mind as you read this article that we are discussing Constitutionally dictated entities.

"Driven by their peculiar myopic view of the world, Jewish activists continue to agitate for the release from prison of Israeli spy-and American traitor-Jonathan Pollard. Placing their loyalty to Israel above America's national security and emotionally fired by their tribal zeal, such Zionist zealots as New York Democratic Reps. Charles Schumer and Gary Ackerman are leading the charge in Congress to free the confessed Israeli agent."

"At a rally on Capitol Hill last month attended by 300 Pollard supporters, Schumer pandered to the crowd of Israeli sympathizers, saying that Pollard has 'rotted in jail long enough.' Ackerman, the only member of Congress to visit the traitor in prison, scolded his Jewish colleagues for their silence on the issue."

"Also, last month Israeli Prime Minister Yitzhak Rabin, during his White House visit with President Clinton, urged that Pollard be given his freedom. Afterward, Clinton told an Israeli reporter, 'I cannot make a decision on the Pollard case until the Justice Department makes a recommendation to me.' Then attempting to please his guests, Clinton said, 'I do not have to follow the recommendation of the Justice Department, but under our procedure, I have to get one.' "

"Justice and Defense Department spokesmen refused to comment on the president's remarks. However, Deputy Attorney General Phillip Heymann and the department's pardon attorney are expected to make a recommendation to Attorney General Janet Reno in the next few weeks. Reno will then advise the president, who has said that he will make a decision on Pollard soon."

"Meanwhile, the Israeli spy, who is presently being held at the federal minimum security facility in Butner, North Carolina, has announced his engagement to Esther Zeits, head of

the Canadian Jewish committee lobbying for his release. If all goes well, the couple plans to be married in Israel this coming spring."

"The recent ruling by the federal appeals court in Cincinnati overturning the Justice Department's 1985 extradition of John Demjanjuk to Israel to stand trial as Ivan the Terrible of Treblinka has infuriated the Jewish community. Although angry that the court found the department's witch-hunting unit, the Office of Special Investigations (OSI), guilty of 'fraud on the court' and 'prosecutorial misconduct,' the community is particularly incensed by the court's criticism of the OSI's incestuous relationship with the [Anti-Defamation League](#) (ADL)."

"On top of this, Attorney General Reno has promised to review the ethical standards of the OSI's prosecutors in the Demjanjuk case and the earlier deportation case of Andrija Artukovic, who later died in a Yugoslav jail. Artukovic's attorneys say that the OSI knowingly used false evidence manufactured by the Soviet Union to accuse their client of war crimes, which were never committed. A department spokesman said two weeks ago that 'there are at least those two cases being reviewed.'"

"Leading the Jewish howl over these developments is Harvard law professor Alan 'Chutzpah' Dershowitz. 'If the Demjanjuk standard applied universally to all criminal cases,' said the nearly hysterical defense consultant to Israeli agent Pollard, 'prison doors around the U.S. would be flung wide open and tens of thousands of convicted prisoners would be freed.' "

"Rep. Schumer, one of the Israeli spy's leading supporters, urged Attorney General Reno to fight the Cincinnati court's decision. 'After reading the court decision, I'm infuriated at what is as close to blatant antisemitism as I've ever seen in a legal opinion,' the congressional Zionist told Jewish journalists." End of quotes.

Note that it is the same zealot Rep. Charles Schumer wanting to free the pro-Israeli and anti-American traitorous spy Jonathan Pollard who is at the same time violently condemning the federal appeals court for overturning the Department of Justice's extradition of John Demjanjuk. It is this same Charles Schumer who is the current driving force in Congress for the confiscation of weapons in the hands of American citizens.

Notice also that it will be Deputy Attorney General Phillip Heymann who will "advise" the Attorney General who will then "advise" the president as to whether Pollard should be released. It was also this same Phillip Heymann who was associated with the "independent review" of the Department of Justice's participation in the Waco siege and conflagration.

It should be of interest to know that Zionist Jonathan Pollard, a convicted spy and traitor to the United States of America is "languishing" in a minimum security prison which, compared to a prison like the one at Marion Illinois, is a country club type resort. "Politically incorrect" prisoners such as Yori Kahl and Scott Faul were sentenced to maximum security prisons, including the "hole," for 130 years because of their beliefs.

The Change Of Leadership In Government

The Co-Presidents of the United States have been bold and brazen in their appointments to high offices within the government. It is important to list some of these appointments at this time because it will give us an insight into their agenda.

Over 50% of the major cabinet level posts are now filled with Zionists. Further, the cabinet level posts are those, which generally are responsible for foreign trade and commerce. As we continue with this newsletter we will see the importance of this.

The Secretary of Labor is Robert Reich. The appointed head of Economic Advisors is Robert Rubin. Roger Altman is now Asst. Secy. of the Treasury. The U.S. Trade Representative is Mickey Kantor. Alice Rivlin is the new Director of Budget. Madeliene Albright is Ambassador to the U.N.

To force the demands of the United States on the Third World Nations requires a change in command in national intelligence and the military. To this end a new appointment was made with Samuel Berger to be Head of National Security. Morton Halperin was named Asst. Secy. of Defence.

Patrick Buchanan recently wrote an excellent article about Morton Halperin. Buchanan stated, "Halperin is said to be chief architect of the scheme to have the U.S. build a New World Army for the UN's New World Order, a scheme outlined in the now-famous Presidential Decision Directive 13."

"Under PDD-13, the Pentagon is to build a military command structure for Secretary General Boutros-Ghali, give UN officials access to U.S. intelligence, and transfer U.S. troops to UN command." End of quotes.

The Presidential Decision Directive 13, as reported in Buchanan's article, shows that the UN officials would be given access to U.S. intelligence. Thus, we have the appointment of Samuel Berger to be Head of National Security.

To assure compliance with the proposed National Health Care Act, David Kessler was named Commissioner of the Food and Drug Administration. Assisting him with the "Kosher tax" will be Rabbi Aharon Kahn.

An extremely interesting and informative book on the women appointments made in the new government is entitled *Big Sister is Watching You* by Texe Marrs. This book is highly recommended reading. On the cover itself is the statement, "Hillary Clinton and the White House Feminists who now control America-and tell the President what to do." Texe Marrs does a superb job describing the background and beliefs of each of these women appointees. We should note that Judaism is a matriarchal society. More UN Agenda

There are three major efforts occurring that directly apply to the New World Order. They are: Population Control, North American Free Trade Agreement (NAFTA), and Clinton's Health Plan entitled "Health Security Act."

Background. Past Lessons in History have extensively discussed the British Oligarchies and their efforts to reacquire the United States as a part of their empire. We have shown how these oligarchies created wars and revolutions. They organized the British East India Company to subjugate India. They forced the production of opium on India and then forced the opium on the Chinese, which caused the Chinese Opium War. They systematically forced the Indian people into rural areas and then forced famine, which is generally known as genocide.

Back in England, around 1860, Richard Cobden negotiated a treaty with Napoleon III of France which was a trade treaty resulting in lower tariffs between England and France.

That trade treaty permitted the two countries to increase the efforts of forcing opium on the Chinese people. This was done under the umbrella of the Cobden trade treaty. Because of that treaty, the British gave Indochina (Vietnam) to France. That is why Vietnam was under the rule of France before the Vietnam "police action." What we saw in the Korean and the Vietnam wars was nothing but a continuation of the efforts in India to regulate the production and population growth of these countries. More of these details will be given in a future history lesson on the French Revolution.

When Cobden died in 1865, his name was given to a club simply titled the Cobden Club and the stated purpose of the club was to honor Cobden, the "APOSTLE OF FREE TRADE." We emphasized that title because of the relationship the Cobden Club has with what is now going on in the United States and elsewhere. This will become more apparent as we continue.

Interestingly, the Cobden Club had, and still has, many members within the United States. In past Lessons in History we showed that Henry Adams, the grandson of President John Quincy Adams was a member of the Cosmos Club, which was directly involved in the depopulation of the American West in the name of protecting the environment. Henry Adams was also a member of the Cobden Club as were other Americans, holding membership in both organizations.

From this we can readily understand that they were interested in depopulation, free trade, and drug distribution. The purpose was to make huge sums of money by exploiting cheap or slave labor and then kill them with drugs, all in the same time frame.

The Cobden Club has continued to this very day and their goals are the same now as they were over 100 years ago. They are directly and intimately involved in the United Nations, One World Government, free trade and the depopulation of the world. Think not that the United Nations is dedicated to SAVING lives!

The very well written newsletter *Frontiers of Freedom*, 10235 S.E. 13th Place, Bellevue WA, 98004 has recently released a report on population control. That report revealed a meeting of the United Nations Association of Iowa, on September 22, 1991. The purpose of the meeting was to help prepare the agenda for the United Nations ECO-92 Summit meeting of 1992. A very revealing letter, written by the Cobden Club, was distributed to the attendees. For the purpose of brevity we will extract the pertinent parts of that letter entitled "Initiative for ECO-92 Earth Charter":

"1. The Pressing Need. a. The time is pressing. The Club of Rome was founded in 1968. Limits of growth was written in 1971, Global 2000 was written in 1979, but insufficient progress has been made in population reduction."

"b. Given global-instabilities, including those in the former Soviet bloc, the need for firm control of world technology, weaponry, and natural resources, is now absolutely mandatory. The immediate reduction of world population, according to the mid-1970's recommendations of the Draper Fund, must be immediately effected."

"c. The present vast overpopulation, now far beyond the world carrying capacity, cannot be answered by future reductions in the birth rate due to contraception, sterilization, abortion, but must be met in the present by the reduction in the numbers presently existing. This must be done by whatever means necessary."

"d. The issue is falsely debated between a political and a cultural approach to population and resources, when in fact, faced with stubborn obstruction and day-to-day political expediency which make most of the leaders of the most populous poor countries unreliable, the issue is compulsory cooperation."

"e. Compulsory cooperation is not debatable with 166 nations, most of whose leaders are irresolute, conditioned by localist 'cultures,' and lacking appropriate notions of the New World Order. Debate means delay and forfeiture of our goals and purpose."

"f. The U.N. action against Iraq proves conclusively that resolute action proves that the aura of power can be projected and sustained and that the wave of history is sweeping forward."

"What Must be done. In the face of mounting opposition from Third World elements, certain forces in the Eastern European and Russian regions, and by the Vatican, and certain weak-kneed response within the ecology effort, what really is the purpose of traipsing around America to convince a handful of farmers, unionists, local officials, churchmen, and university environmentalists of the necessity of the Earth Charter? If one truly wished to convert the American public, would it not be necessary to say fully, openly and explicitly what must be done? And that it must be done now?"

"Do you really imagine that parading some Third Worlders before 'hearings' conducted by local celebrities, the Third World will simply quiet down, or that the American press coverage of these events will overwhelm this opposition?"

"Will you take action now that President Bush (written in 1991-ed.) has the political momentum or wait until you must convince America to fight a hundred Vietnams simultaneously? This is the time to save the Anglo-Saxon race and its most glorious production, the Anglo-Saxon system of BANKING, INSURANCE AND TRADE." (emphasis mine-ed.) End of quotes.

Before we continue with this letter and include the United Nations participation in this plan, it is necessary to show what they really mean by the phrase "to save the Anglo-Saxon race and its most glorious production, the Anglo-Saxon system of banking, insurance and trade." Their use of the words "Anglo-Saxon race" as a misnomer. In using those words they have caused the people of the world to misunderstand the true Anglo-Saxon. It was not the Anglo-Saxon who developed the banking, insurance and trade system of the British Empire. As was explained in past history lessons that development came after William the Conqueror with his Jewish money lenders came from Rouen, France in 1066. The one-square-mile "City of London" was the very start of the Admiralty System, the Law of Equity system, and the Universal Commercial Code system.

It wasn't that the "sun never sets on the British Empire." It is more appropriate to say that the sun never sets on the graves of the genuine Anglo-Saxons who died to make that "glorious production." It was that system, started as early as William the Conqueror which caused the Magna Carta to be written. That same system caused the great eviction of the Jews in 1290 by King Edward I. But all that was just the start. It was Oliver Cromwell who made a deal with Mannasseh Ben Israel that, with a marriage, literally and figuratively, between the nobility of England and the Jews with their money, "they" would rule the world. And that they did.

As the British author Hilaire Belloc said in his book *The Jews*, "And the Jew pointed to the English State as that one in which all that his nation required of the goyim was to be found. He here enjoyed a situation the like of which he could not hope to enjoy in any other country of the world. All antagonism to him had died down. He was admitted to every

institution in the State, a prominent member of his nation became chief officer of English Executive, and, an influence more subtle and penetrating, marriages began to take place, wholesale, between what had once been the aristocratic territorial families of this country and the Jewish commercial fortunes."

"After two generations of this, with the opening of the twentieth century those of the great territorial English families in which there was no Jewish blood were the exception. In nearly all of them was the strain more or less marked, in some of them so strong that though the name was still an English name and the traditions those of a purely English lineage of the long past, the physique and character had become wholly Jewish and the members of the family were taken for Jews whenever they traveled in countries where the gentry had not yet suffered or enjoyed this admixture." End of quotes.

The genuine Anglo-Saxon has been forced to take the insults and punishment of the entire world because of what only a few of those who call themselves Englishmen have done. True, the ordinary Englishman has fought their wars and acted as their "world policeman." We can state that he only needed to say "no." But then, it is now our turn to fight their wars and act as the "world policeman." Are our troops going to say "no?"

After the British Empire began to crumble, greatly because the world learned to loathe that admixture Hilaire Belloc described, the United States accepted the role. We now are doing the same thing, at first figuratively, but now literally, which led England down the primrose path of destruction. Continuing with the United Nation's participation as written in the Cobden Club letter:

"Therefore the following must be implemented: The Security Council of the U.N., led by the Anglo-Saxon Major Nation powers, will decree that henceforth, the Security Council will inform all nations that its suzerainty on population has ended, that all nations have quotas for reduction on a yearly basis, which will be enforced by selective or total embargo of credit, items of trade including food and medicine, or by military force, when required."

"The Security Council of the U.N. will inform all nations that outmoded notions of national sovereignty will be discarded and that the Security Council has complete legal, military, and economic jurisdiction in any region in the world and that this will be enforced by the Major Nations of the Security Council."

"The Security Council of the U.N. will take possession of all natural resources, including the watersheds and great forests, to be used and preserved for the good of the Major Nations of the Security Council."

"All of the above constitute the New World Order, in which Order, all nations, regions and races will cooperate with the decisions of the Major Nations of the Security Council."

"The purpose of this document is to demonstrate that action delayed could well be fatal. All could be lost if mere opposition by minor races is tolerated and the unfortunate vacillations of our closest comrades is cause for our hesitations. Open declaration of intent, followed by decisive force is the final solution. This must be done before any shock hits our financial markets, tarnishing our credibility and perhaps diminishing our force." End of quotes from the Cobden Club letter.

So, it is greatly the efforts of the Cobden Club, which is the driving force within the Club of Rome, the Trilateralists, and the Council of Foreign Relations, which is directly involving the Western nations in the internal affairs of the Third World. By what authority and what justification is this accomplished? The founder of the Cobden Club was Richard Cobden, "the apostle of free trade!" Richard Cobden, and his cohorts, were directly involved in the British

East India Company, which was the originator of wholesale drug running, money laundering, slave labor sweat shops and manipulating foreign countries and their governments. As we now project this forward to the present time we can now discuss the North American Free Trade Agreement (NAFTA) and the General Agreement On Trade and Tariffs (GATT).

NAFTA

We here at *Christian Crusade for Truth* have been speaking out against NAFTA, and its forerunner "Maquiladoras," whenever we have had the opportunity for the past eight to ten years. It has been pointed out that, even if one could justify the trade agreement on the basis of the economy, the entire concept is so evil that the very roots of our sovereignty, freedom, liberty, and our ethnic Nationhood are at stake.

We have already discussed what "free trade" did for England through their various international companies such as the British East India Company, which are now called multinational corporations. We see how they developed the drug trade, money laundering and foreign manipulation. Most importantly, we saw how the money and the government "married" to make it work. We have already shown just some of the new appointments in the Clinton Administration and how that fits perfectly with the system developed in England.

The system to allow for the importation of huge amounts of drugs into the United States is being developed. The drug cartels are now buying "twin-plants," one on each side of the Mexican border. They are buying fleets of transport trucks to haul the manufactured goods, made in Mexico by workers at fifty cents per hour wages, into the United States. When these goods are distributed in the United States, they will be sold to Americans who are now working at McDonalds turning hamburgers and cleaning the toilets and offices of the multinational corporations. Those are the large, all glass buildings we see in the cities! The New York Stock Exchange will show huge profits and gains in the worth of stocks but that will only reflect the gains made by those multinational corporations, not the worker in what they now lovingly call the "rust belt."

However, those trucks, owned by the cartels, will be hauling drugs, along with the goods for sale. A "sweetheart deal" was made some time ago that allowed for the corporations at their plants in Mexico, to "assure" the U.S. Customs that the cargo in the trucks has been inspected. They then put a seal on the doors and have free access to all of the highways of the United States! The [Drug Enforcement Agency](#) (DEA) has already complained about this arrangement. If that loophole is closed, another one will open somehow. We can be assured that NAFTA will be a conduit for the major shipment of drugs. The Chinese Opium War in being repeated, only this time it is in the United States.

One of the major reasons the multinational corporations went to Mexico was to circumvent the environmental restrictions forced upon production plants here in the United States. They have moved to Mexico and the pollution is now so bad in places in Mexico that people are becoming sick. Farm animals and chickens, pets and even children are dying from drinking the polluted water.

The American government of course is a benevolent government (sic)! They are now preparing for an environmental cleanup of the Mexican border area to remove those pollutants. If the companies had their plants in the "rust belt," they would be forced to pay for that cleanup, as well as pay a fine (tax). But the "generosity" of the American taxpayer will pay for the cleanup in Mexico that these companies created. In addition, American money will be spent to "beautify" the Mexican landscape by removing the cardboard shacks (called colonias) in which the peasant class in Mexico lives. The government is even going

to be generous enough to clean up the colonias on the American side of the border. These colonias came as a result of the huge influx of Mexican immigrants (legal and illegal) that our government permitted, even encouraged, to come into our country.

Above all of this, our sovereignty is being destroyed. In the magazine *Cronicles: A Magazine of American Culture*, Rockford Illinois, May 1993, is a very interesting article. It is a lesson in sovereignty:

"NAFTA-the North American Free Trade Agreement-is not unlike the notorious star chamber, where the king and counselors of medieval England secretly meted out justice without concern for precedent. (Actually, the star chamber court was a special court to protect the special arrangements between the king and the Jews with their money lending. Hilaire Belloc in his book *The Jews*, said this, "When Jews lent money on security the King was party to the safe custody of the security, and their privilege extended so far that they were exempt from the common law, and a case between an Englishman and his Jewish creditor could only be tried by a mixed jury in which the Jew's own compatriots were present in equal numbers with the English." (That was the star chamber. Also, think about that in terms of modern America.- ed.)

"If Congress approves NAFTA, George Bush's proudest diplomatic achievement, Americans can expect a heavy dose of star-chamber style justice in the 21st century. For the average citizen, NAFTA is a formidable document. It extends some two thousand pages and reads with all the elegance of a mortgage contract. Behind the cumbersome sentences and passive verbs lie revolutionary concepts cloaked in innocuous words. At first glance, Article 20 (relating to dispute-settlement procedures) appears a harmless monument to the drafting skills of disciplined international lawyers. But a closer reading reveals the mischievous fingerprints of incremental internationalists, the modern-day gnomes of Switzerland who sit around Geneva drafting codes for the New World Economic Order. Indeed, the spirit of Geneva runs rampant at the U.S. Trade Representative's Office in Washington. To write NAFTA, the gnomes of USTR drew heavily on dispute-resolution proposals advanced in the Uruguay Round deliberations of the General Agreement on Tariffs and Trade. Eager to rationalize and harmonize international trading practices, they have done the legal equivalent of reinventing the wheel. They have revived the medieval star chamber. (As shown in Clinton's cabinet level appointments, Mickey Kantor is the U.S. Trade Representative-ed.)"

"Instead of relying on an independent and impartial judicial system based on established law, NAFTA's Article gives extraordinary latitude to ad hoc dispute-settlement panels. NAFTA panels have authority to conduct hearings away from the glare of public opinion. Hearings, deliberations, and reports will all remain confidential, except to governments. Indeed, final panel reports need not be published. The five-member panels are not composed of experienced and independent justices insulated from popular passions and politics, like United States courts (sic). Instead, the panelists are appointees, selected from a roster of lawyers and trade experts, for temporary assignment. Most of them are individuals beholden to governments and special interests for future employment."

"Nor does precedent bind their decisions. Mexican and American law have different origins. The former reflects the Napoleonic imprint of statutes; the latter, the English Common Law. Thus, there is no common body of law, except for the agreement, and Article 20 makes no reference to national precedents. "

"...Americans should not dismiss NAFTA panels as toothless tigers in the fictional jungle of international commercial law. For they may soon prevail over domestic courts and encroach on the authority of Congress and individual states. They may reapportion

sovereignty between states and the federal government, upset the separation of powers among the three branches of federal government, and subordinate the independent federal judiciary to the law of NAFTA. Once a NAFTA panel submits its finding, governments party to the dispute must resolve the conflict either by removing measures not conforming to NAFTA or by paying compensation."

"Article 20, in particular, has far-reaching implications for the 50 states. Traditionally, as a result of the Tenth Amendment and its 'commerce clause,' states have regulated banks and insurance companies and set standards for licensing services and professionals. As a consequence of NAFTA, they may soon have to treat Mexicans and Canadians the same as Americans as well as offer them equal opportunities to compete."

"Another specific NAFTA provision, Annex 2004, has even more ominous significance. Annex 2004 allows a party to NAFTA to invoke dispute settlement when it believes a measure to be inconsistent with the agreement to an impairment to benefits it could reasonably have expected to accrue. In essence, if Mexico thinks one of the 50 states is doing something to hinder gains it might have anticipated, it can insist on dispute settlement, relying on the caprice of panels. Environmentalists and consumer activists, as well as conservatives, interpret this provision as a usurpation of state rights. Indeed, NAFTA could eliminate experimentation of any kind, liberal or conservative, at local levels in response to complaints from foreign citizens." End of quotes from the magazine *Chronicles*.

Well, there we have it. We have given an overview of current events of the so-called New World Order. This new world order is not new at all. What we see now is nothing but a continuation, or rebirth, of the British Empire system. XXXVIII In the future no bailiff shall upon his own unsupported accusation put any man to trial without producing credible witnesses to the truth of the accusation.

XXXIX No free man shall be taken, imprisoned, disseised (dispossessed), outlawed, banished, or in any way destroyed, nor will we proceed against or prosecute him, except by the lawful judgment of his peers and by the law of the land.

XL To no one will we sell, to none will we deny or delay, right or justice.

XLII In the future it shall be lawful (except for a short period in time of war, for the common benefit of the realm) for anyone to leave and return to our kingdom safely and securely by land and water, saving his fealty to us. Excepted are those who have been imprisoned or outlawed according to the law of the land...

XLVII All forests which have been created in our time shall forthwith be disafforested. So shall it be done with regard to rivers which have been placed in fence in our time.

LI As soon as peace is restored, we will banish from our kingdom all foreign knights, bowmen, attendants, and mercenaries, who have come with horses and arms, to the kingdom's hurt.

LII If anyone has been disseised or deprived buy us, without the legal judgment of his peers, of lands, castles, liberties, or rights, we will immediately restore the same."

Here is an excerpt from Patrick Henry's speech in 1775: "Is it that insidious smile with which our petition has been lately received? Trust it not, sir; it will prove a snare to your feet. Suffer not yourselves to be betrayed with a kiss. Ask yourselves how this gracious reception of our petition comports with these warlike preparations which cover our waters and darken our land. Are fleets and armies necessary to a work of love and reconciliation? Have we shown ourselves so unwilling to be reconciled, that force must be called in to win back our love? Let us not deceive ourselves, sir. These are the implements of war and subjugation; the last arguments to which kings resort. I ask gentlemen, sir, what means this martial array, if its purpose be not to force us to submission? Can gentlemen assign any other possible motives for it?"

The Cobden Club letter gives us a clue to their present haste in finishing their work. "The purpose of this document is to demonstrate that action delayed could well be fatal. All could be lost if mere opposition by minor races is tolerated and the unfortunate vacillations of our closest comrades is cause for our hesitations. Open declaration of intent, followed by decisive force is the final solution. This must be done before any shock hits our financial markets, tarnishing our credibility and perhaps diminishing our force." End of quotes.
