### Craft Vendors Application

#### Instructions

##### Friday, June 7<sup>th</sup>:

- Check in begins at 7:00AM
- Be ready for business at 3:00PM
- Booths open from 3:00PM until Dark
- Vendor Parking will be only at Lot E. Division Street
- Parking will not be allowed on 1<sup>st</sup> Avenue NE and Division Avenue E.

##### Saturday, June 8<sup>th</sup>:

- Booths open from 10:00AM until Dark

#### Festival Rules

1. Your Application will be considered incomplete and placed at the bottom of the stack, **if the Applications is not complete or your fees and deposit are not enclosed.**
2. Check in at the Sage-N-Sun Family Festival Booth located near the South Side of the Grant County Courthouse Step and begins at 7:00AM.
3. Set-up begins Friday at 7:00AM. Must be ready for business at 3:00PM
4. Craft Vendors will not be able to access C Street, until all Food Vendors have parked their trailers or booths.
5. Vendors may close when they feel is it too dark for them to operate, however no earlier than 1/2 hour before dusk. Vendors may operate after dark and will be strictly up to the vendor. Under no circumstance will any vendor close early unless there is an emergency and Jeanette Cole has been notified or refunds will be forfeited.
6. Vendor Parking will be only at Lot E, Division Street. There will be no exceptions.
7. No vehicle movement at the Grant County Courthouse and surrounding streets before 10:00PM. NO EXCEPTIONS or your deposit will be forfeited.
8. Vehicles and trailers are only allowed in the display area to load and unload. You must remove your vehicle before you set up your space. This allows other Vendors to get in and unload. All Vendor's Vehicles must be removed from the parking lot prior to 3PM on Friday and are not allowed to return until the close of the Festival on Saturday Evening.
9. Pets must be on a leash. You must clean-up after your pets or your deposit will be forfeited.
10. NO ALCHOLIC BEVERAGES, DRUGS and/or DRUG PARAPHRNALIA will be allowed at any of the Vendor Booths at any time. This is a Family Festival.
11. SMOKING IS NOT ALLOWED at the Grant County Courthouse at any time! This includes the parking lots. You must go outside the road closure signs to smoke.
12. Cigarettes, Vapes, Obscene, Vulgar, Lewd, Racist or Sexually Oriented language/Materials are prohibited. In other words, the Festival is strictly PG-13.
13. Booth structures and contents, including inventory are the responsibility of the Vendor. The Festival, Grant County or the City of Ephrata do not assume any responsibility for injury to persons, loss or damage to any property of the Vendors, including but not limited theft, accidents or acts of God. However, the Festival will provide a minimum one (1) security guard who will be patrolling the grounds Friday. **There will be no Security for Saturday Night.**
14. There is no overnight parking or camping in or around the Grant County Courthouse.
15. **STAKES ARE NOT ALLOWED TO BE DRIVEN INTO THE GRANT COUNTY COURTHOUSE LAWN AT ANYTIME! SANDBAGS OR CINDER BLOCKS ARE ALLOWED! NO VEHICLES ALLOWED ON COURTHOUSE LAWN AT ANYTIME!!!!**
