Budget/Actual Report

- Audit/legal, cleaning items, small items line items are no longer appearing on report. Need to investigate why.
- On April's report the first line/first column was questioned as to correctness. Will investigate.
- Within the contingency line item, it was suggested that \$200 be used to pay for a UARRC Zoom account.

Crushed Glass:

- During meeting with USDA grant representative, it was discussed that she might have a market for our crushed glass.
 - The need for the crushed glass is to provide an inert material for lithium battery storage and shipment.
 - UARRC is required to send a 1-gallon sample to the lithium battery vendor for examination and analysis.
 - A motion was made to send out a 1-gallon sample to the lithium battery vendor for suitability testing. Seconded. Vote: For (5)/Against (1)/Abstain (1).
- Crushed Glass Research
 - DEP considers crushed glass as inert fill.
 - Examples of the use of inert fill is as a drainage media, as a fine aggregate in a concrete mix, or as use in a sandblasting media.
- A suggestion was made that instead of sending the media to a lithium battery vendor that UARRC sell the product for a \$1/10 lbs. It was mentioned that UARRC is a nonprofit entity, and the selling of a product could affect that designation.
- Discussed signage of crushed glass as "Inert Fill".
- Also suggested that no matter what the ultimate decision on the fate of the crushed glass that one 55-gallon drum be set aside for resident's use.
