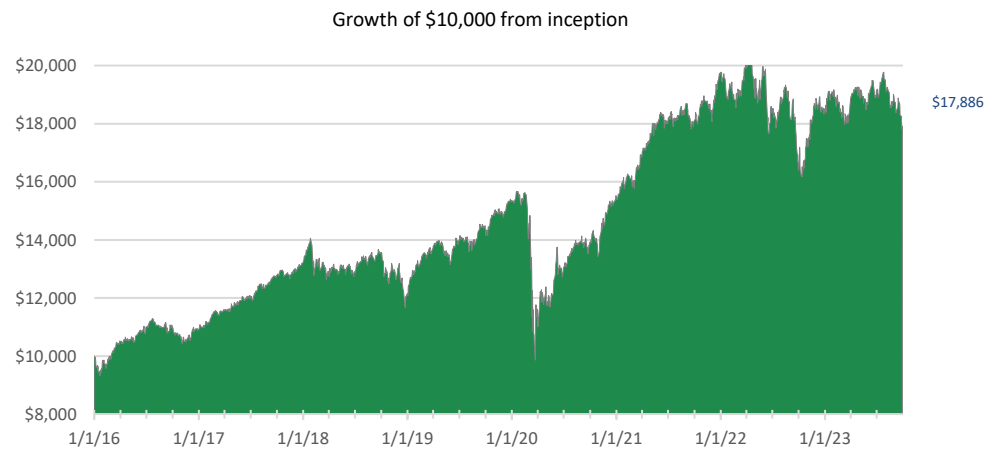

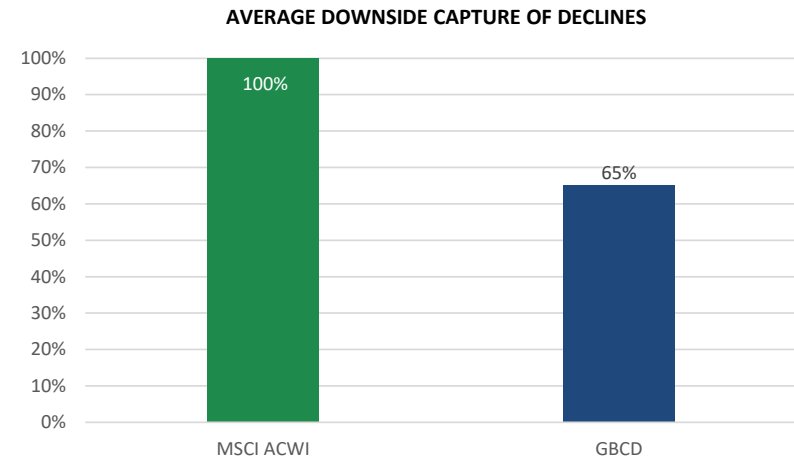
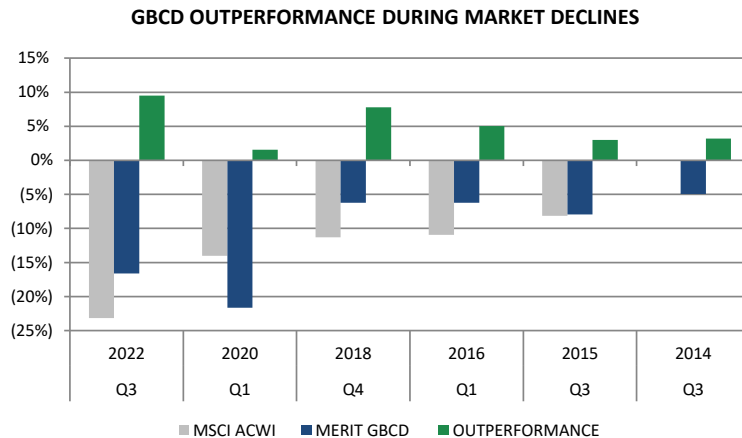
HISTORICAL PERFORMANCE ANALYSIS

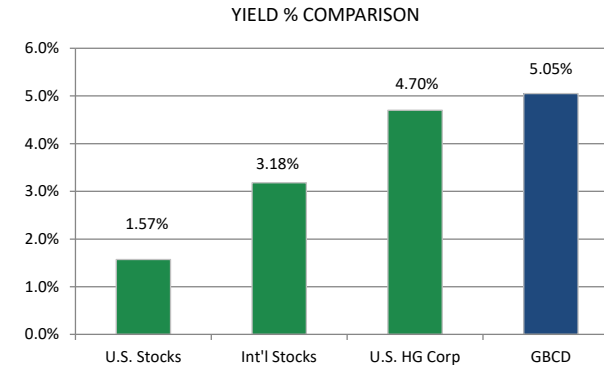
DIVIDEND YIELD & RISK METRICS

The Global Blue Chip Dividend Strategy offers a higher yield and exhibits significantly lower volatility & risk

DIVIDEND METRICS

- GBCD yield of 5.1% is higher than U.S./Int'l equity indexes of 1.6%/3.2%
- GBCD yield of 5.1% is comparable to the IG Corp Bond index of 4.7%
- Solid dividend yields across all sectors ranging from 2.1% to 9.8%
- Strong dividend income with equity upside and inflation hedge

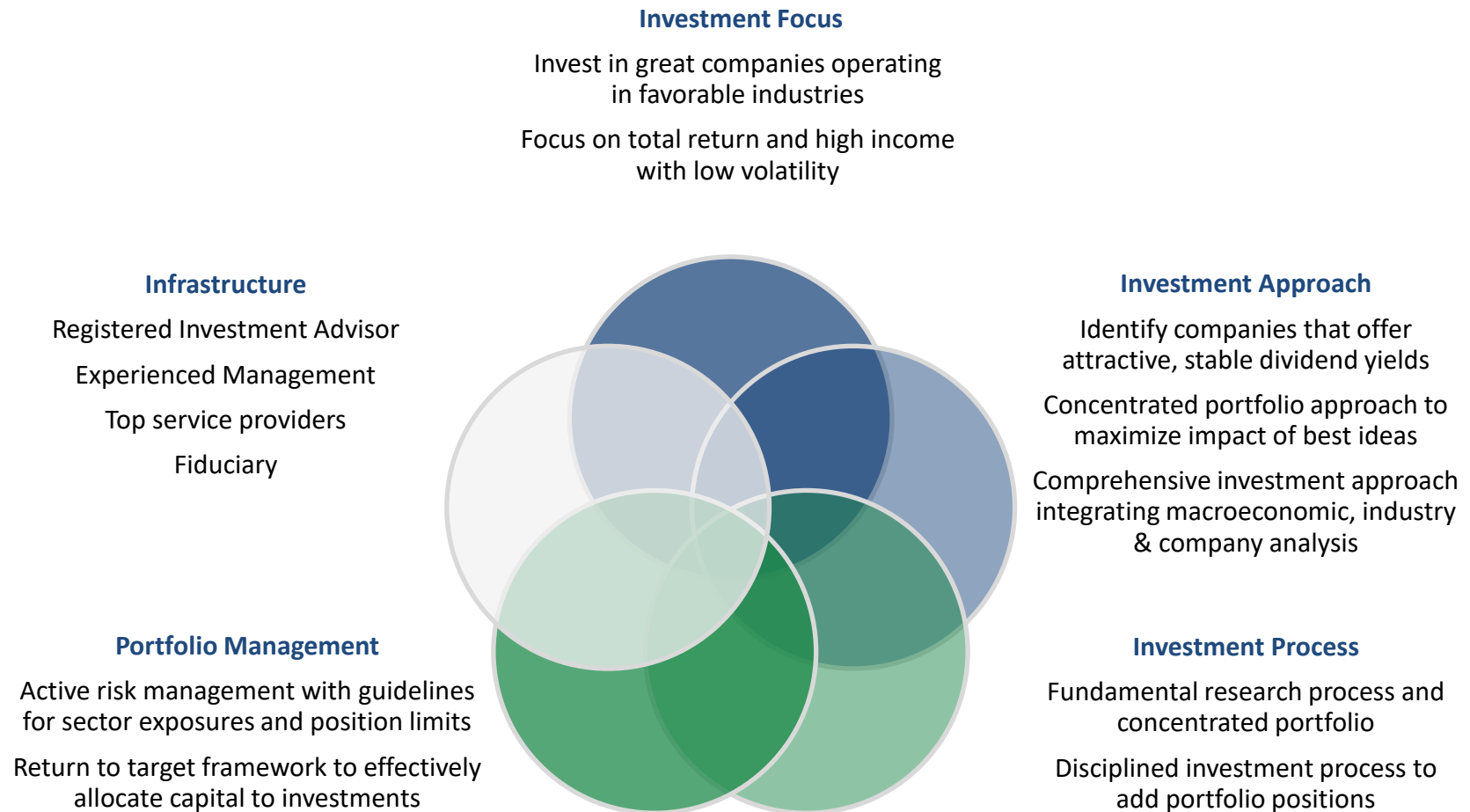
