I freely accept and fully assume all such risks and the possibility of personal injury, death, property damage, expense and related loss, including loss of income. KGC reserves the right to cancel classes due to weather or other unforeseen circumstances and there will be no refund or make up for those classes.

Release of Liability

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of Kawartha Gymnastics Club accepting my application to participate in this activity, I agree:

1. To waive any and all claims that I may have in future against Kawartha Gymnastics Club and others.
2. To release the Kawartha Gymnastics Club and others from any and all liability for any personal injury, death, property damage, expense and related loss, including loss of income that I or my next of kin may suffer as a result of my participation in this activity, due to any cause whatsoever, including negligence, breach of contract or breach of any statutory duty of care.
3. To hold harmless and indemnify Kawartha Gymnastics Club and others from any and all liability for any damage to property of or personal injury to, any third party, resulting from my participation in this activity.
4. That this agreement is binding on not only myself but my next of kin, heirs, executors, administrators, and assigns.

I have read this agreement and understand it. I am aware that by signing this document I am waiving certain legal rights which I or my next of kin, heirs, executors, administrators and assigns may have against Kawartha Gymnastics Club and others.

Recreational/Advanced Recreational Monthly Program Refund Policy:

There are no class refunds except for medical reasons which must be accompanied by a medical note at the time of withdrawal. Withdrawal for medical reasons will be prorated based on the number of remaining classes. For all other reasons please submit an online withdrawal form.

Automatic Payment Policy (Recommended):

Upon registration your first month's fees as well as annual Gymnastics Ontario Fee (\$30) are due. Monthly fees are processed automatically by credit card or bank draft on the 1st of each month. NSF will be a charge of \$25. Overdue accounts (including NSF fees) must be paid in full prior to the 2nd class or the child will not be admitted into class, which will result in termination of child's spot.

Payment Policy – Automatic Opt Out:

Monthly fees will be posted to your account on the 16th of the prior month. Payment in full must be made by the 1st of each month. On the 2nd day of each month a \$25 late fee will be posted to unpaid accounts. Payment in full, including late fees, are required prior to the 2nd class or the child will not be admitted into class, which will result in termination of child's spot.

Program Withdrawal:

Our recreational & advanced rec program runs on an ongoing monthly basis. Upon registration your spot is yours September to June. To withdraw from a class at anytime you must submit an online Withdrawal Form by the 15th of the month that you want to leave. For example, if October is your last month attending your withdrawal form must be submitted by October 15th to be processed. Online withdrawal forms are available on our website under the "Recreational" tab or by contacting our office - admin@kawarthagymnastics.ca.

Makeup Classes:

We offer makeup classes for gym related cancellations including holidays, meet hosting, fundraising events, and inclement weather conditions. Students may do a makeup in any class within the same age group. Makeups are open to currently enrolled students only and do not expire (as long as the student is enrolled), have no cash value, and cannot be used in lieu of payment for classes.
