- **In that position he served as the United States sherpa to the G7, G8, and G20 summits of economic powers.**
- **On May 2, 2013, President Barack Obama nominated him to succeed Ambassador Ron Kirk as the U.S. Trade Representative. He was confirmed on June 19, 2013.**
- **He has a J.D. from Harvard Law School where he was a classmate of Barack Obama, and also where he was an associate of Obama's on the Harvard Law Review.**

- Froman introduced Obama to Wall Street people for contributions for his campaign.
- Perhaps the most startling discovery of the WikiLeaks dumps so far didn't come from the most recent emails surrounding the various Hillary scandals, though there are many great ones, but from 2008 when **John Podesta served as co-chair of President-elect Barack Obama's transition team.**
- The email came from **Michael Froman, a former Citibank executive, who single-handedly built the entire cabinet of what was supposed to be the "main street" President.**

- **And the lack of transparency means that lawyers acting as arbitrators or advocates in one case could be unnamed investors in other cases, and nobody would ever know.”**
- And the TPP would significantly expand the powers of the ISDS.

- **According to Public Citizen, the TPP would open the doors for 9,000 companies to gain ISDS rights to sue the United States government.**
- **The ISDS is a threat to the economy and to our political rights.**
- **Seeing this, I thought that Barack Obama and Michael Froman should be brought up on charges in the International Criminal Court for Stealth Kleptocracy for allowing the Investor-State Dispute Settlement system to be manipulated by Wall Street for rigged profit-loss law suits.**
