Special Purpose Entity Opportunity

An SPE, or Special Purpose Entity is a new class of pass-through partnerships that exist solely for the purpose of obtaining Education Improvement Credits (EITC/OSTC). You can redirect your PA state taxes to St. Teresa of Calcutta Catholic School. If you have a minimum PA tax liability of \$3,500 or more, you qualify for the program. Signing up for a two-year commitment will get you a 90% tax credit.

For example, if you pay \$4,500 in PA taxes and join the SPE program and make a contribution of \$5,000, you will receive a 90% tax credit. This will result in a \$4,500 tax credit that reduces your PA tax liability to zero. It would only cost you \$500 out of pocket and you can redirect the entire amount of your tax liability to St. Teresa of Calcutta Catholic School. This results in a \$5,000 EITC scholarship for students and 100% of your donation goes directly toward the school!

Follow these easy steps:

1. Determine your eligibility with your accountant
2. Complete and submit Joinder Agreement (provided by STC- please send a copy to STC)
3. Receive approval letter from Special Purpose Entity (Central Pennsylvania Scholarship Fund)
4. Make your contribution to SPE Fund noting St. Teresa of Calcutta Catholic School as the chosen school.

Since beginning this program in October of 2020, we have received \$32,300 in SPE donations that will benefit over 85 of our STC families! With your donations, we are able to offer a Catholic education to families who could not otherwise afford to attend our school. This is truly living out our motto of “doing small things with great love.”
