



**ORDINANCE NO. 04-2018**

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF ROSELAND,  
INDIANA APPROVING THE PETITION FOR SPECIAL USE FILED BY  
THE UNIVERSITY OF NOTRE DAME DU LAC  
FOR PROPERTY LOCATED AT EAST CRIPE STREET  
CONTIGUOUS TO THE EAST AND SOUTH CORPORATION LINES OF  
THE TOWN OF ROSELAND

FILED WITH THE AREA BOARD OF ZONING APPEALS

WHEREAS, The University of Notre Dame Du Lac, Petitioner has heretofore filed a petition seeking a Special Use to allow multi-family dwellings within an R-Residential District.

WHEREAS, The Area Board of Zoning Appeals has acted upon said petitioner and forwarded the same to the Roseland Town Council with a favorable recommendation; and

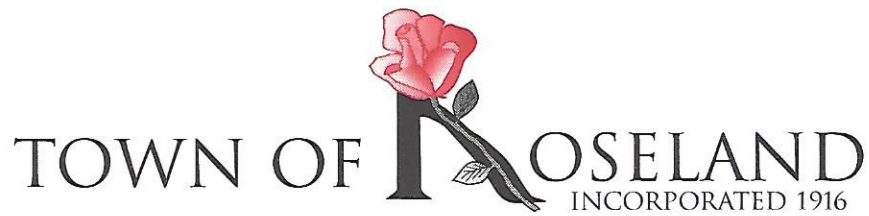
WHEREAS, due notice and public hearing has been given to this petition, and the Roseland Town Council deems it appropriate to approve said petition.

IT IS HEREBY ORDAINED BY THE ROSELAND TOWN COUNCIL, ST. JOSEPH COUNTY, INDIANA THAT:

Section I. The University of Notre Dame Du Lac has heretofore filed a petition seeking a Special Use permit; is hereby approved. The Findings of Fact attached are hereby approved, adopted and incorporated into this ordinance by reference.

Section II. Should any part of this Ordinance be found to be unconstitutional, or invalid for any reason, the remaining portions shall continue in full force and effect.

Section III. This Ordinance shall be of full force and effect from and after its passage by the Town Council of the Town of Roseland, Indiana, approval, and publication as required by law.
