I. Fiscal Update 3:00-3:30pm

- CFO request to HECC/CCWD \$140,000 for 12 months shared between 4 Workforce Boards.
- Accounting services update FSR's were not submitted to CCWD on time by TOC/OWA staff which would cause the state to be out of compliance with the DOL/Feds. This brought a lot of negative attention to OWA's management of the new board's funds.
- TA from Project Masters re: fiscal services They are on contract to help the new boards seamlessly transition accounting services from OWA.

II. Local Plan Update 3:30-4:00pm

- Discuss Feb 4th Strategic Planning Session review Mission and Vision. Unanimously expressed that the Strategic Planning Session went very well. Most individuals felt that it was a step forward.
 - Mission: The East Cascades Workforce Investment Board is an inclusive, responsive and collaborative convener of business, workforce, economic development, education, and community partners who align and direct resources that support solutions to the talent needs of employers and career goals of individuals. – All in attendance agree that the Mission Statement is currently too long.
