COUNCIL MEETING

FEBRUARY 3, 2022 – Amended April 15, 2022

Meeting was called to order by Mayor Patrick Edwards at 7:01 p.m. Roll call: Cathi Fouts, Chris Norman, Chris Wood and John Bartello present. Norman moved and was seconded by Fouts to approve the agenda. Motion carried 4-0.

Guests: Marvin Campbell, Kira Norman, Andrew Inhelder and Ed Philbin

New Business:

- a. Council reviewed the Draft FY 2023 Budget and Max Levy Notice. Council requested full budget be sent to them for further review. County property assessments will be going up.
- b. Set date for the 2023 Max Levy Hearing is scheduled for Thursday, February 17, 2022, at 7:00 pm at Thomas Jefferson Elementary. Bartello moved and was seconded by Fouts. Motion carried 4-0.
- c. Norman moved, seconded by Wood and motion carried 4-0 to appointed Marvin Campbell to the vacant City Council seat. Mr. Campbell was sworn into office by Michael, City Clerk.

Recessed regular meeting to hold public hearing meeting. Fouts moved and was seconded by Bartello to recess regular meeting and open Public Hearing on the Proposal to enter into a General Obligation Corporate Purpose Loan Agreement. Motion carried 4-0.

Discussed the storm sewer repair project. Concerns were voiced from Mr. Philbin regarding the potential loss of a mature tree on his property. Council will consider options regarding tree replacement. No other citizens spoke at the public hearing. Low bid of \$142,000 was received from On Track Construction, LLC from Nevada, Iowa. Inhelder stated that On Track Construction can start as soon as authorized. Fouts made a motion to authorize Inhelder from MSA to accept the low bid of \$142,000 from On Track Construction, LLC. Motion died. Council would like detail on FY 23 budget before moving forward. Michael will forward details from the FY 23 Draft Budget in the next couple of days. The mayor will check into potential early payoff penalties.

Norman moved, seconded by Wood, and motion carried to have a special meeting on Thursday, February 17, 2022, at 7:00 pm at Thomas Jefferson School regarding the Resolution taking additional action on proposal to enter into a Loan Agreement, authorizing the use of a Term Sheet, and setting date for the private placement of General Obligation Corporate Purpose Bonds, Series 2022
