How To Be a Good Dog Owner From Teller County Animal Control

The 20/20 ordinance

Your dog(s) gets a bark complaint, he barks that is what dogs do....in Teller County, the ordinance is 20 audiles in 20 minutes; an audible is defined as a bark, bay, whine, whimper, yelp or howl. If a dog makes noise; it is the owners' responsibility to quiet the dog. The 20/20 ordinance is in place to allow for a delivery person to come to the home or for people passing by and the owner is not present to quiet the dog. Boredom barking is barking for more than 20 minutes and is considered inexcusable and a violation of the ordinance.

Dog-at-large

A dog-at-large is a dog running loose, a dog on leash on another person's property, a dog off leash more than 10 feet from the owner or off leash on another person's property. All of these are in violation of the ordinance and subject to fines. Dogs are to be confined to the owner's property. If a dog is on leash it is unlawful for the dog to be on another person's property. If the dog is off leash it must be within 10 feet of the owner and under voice command and again it is unlawful for the dog to enter other people's property. If a dog is chasing wildlife, the owner is subject to fines by Teller County Sherriff's Department and the State of Colorado, Division of Parks and Wildlife. Anyone witnessing such activity should immediately contact either or both of these law enforcement agencies. In addition the dog can be destroyed for chasing wildlife or livestock.

The term "wildlife" does include migratory birds such as ducks and geese and other waterfowl. The U.S. Federal Migratory Bird Treaty Act of 1918 provides protection for these birds. Any depredation on waterfowl or on a nest by domestic pets can have costly penalties and charges. Specific provisions in the Federal Statute include:

- Establishment of a Federal prohibition, unless permitted by regulations, to "pursue, hunt, take, capture, kill, attempt to take, capture or kill, possess, offer for sale, sell, offer to purchase, purchase, deliver for shipment, ship, cause to be shipped, deliver for transportation, transport, cause to be transported, carry, or cause to be carried by any means whatever, receive for shipment, transportation or carriage, or export, at any time, or in any manner, any migratory bird, included in the terms of this Convention . . . for the protection of migratory birds . . . or any part, nest, or egg of any such bird." (16 U.S.C. 703)
 - Complaints and Animal Control Follow-up

If you have a complaint, contact Teller County Sheriff Department Dispatch, at 687-9652, they may take all the information at that time or forward your call to Animal Control where you may have to leave a message. You can also contact the State of Colorado, Division of Parks and Wildlife at 227-5200. In either case you should give them as much information as possible to enable them to follow-up sooner and thoroughly. The follow-up is at the discretion of the officer, usually the complaint is answered with a warning and subsequent complaints result in additional warnings or fines.

- Teller County Animal Control-the good guys
- Whether it is rescuing pets from a burning home or following up on pets left behind after a foreclosure or

Midland Depot in Divide

The Colorado State Historical Fund (SHF) announced last fall that they will fund the grant request submitted by the Teller Historic and Environmental Coalition (THE Coalition) in April 2011 to stabilize the foundation of the 107-year old Midland Depot in Divide. The grant totals over \$213,000 with 100% local matching funds coming from private/public donors and fund-raisers. This grant will fund a 2year project that is the beginning of a three-phased master plan to stabilize the depot foundation (desperately need before any other work can be done), acquire and transfer the property to a nonprofit organization and preserve the depot and grounds for use as an interpretive park and visitors' center in Divide. Contracts with SHF have been signed, and THE Coalition will be recruiting local contractors to do the work this spring, with actual work beginning late summer 2012. THE Coalition is a 501(c)c3) non-profit corporation established in 2000 with a ongoing mission of facilitating the preservation of the historic, environmental, recreational and scenic resources in and around Teller County, and to broaden public understanding regarding the significance of those resources.
