Cherry Street, from R-1 Single Family Residential to R-2 Multi-Family Residential, Charles Huff Trust owner: Roe acknowledged Huff requesting rezone of this property to R-4 last year; stating with acreage and dwelling units allowed in R-2, he has concerns of traffic with Cherry Street being so narrow and added spot zoning is not preferred. He stated he will vote no and offered Huff a solution of a Minor Subdivision and turn it into 2 lots, both zoned R-1. Huff stated 210 feet is too deep for 2 lots. Huff mentioned having one drive for both lots, and said he asked for R-2 thinking it was the practical thing to do. Roe said he was expressing one person's opinion. Short stated there was a church at the end of the street, shop next door and C-1 across the street, questioning spot zoning. He said it is not the perfect place but he could see it being R-2 because of the surrounding zones.

Mr. Letterman, asking to speak, stated no one lives in the shop or church. They aren't multi-family. Moyers asked if a duplex would be one or two dwelling units. Understood to be two dwelling units in R-2. Hayes stated parking would be part of density also.
