- Rachel: **Treasurer's report** as of October 25, 2023:
  - \* Have \$136,715.46 total. Payments were \$14,361.57. Check for brining to Michigan Chloride Sales LLC in the amount of \$7,504.20 was the largest payment. Revenue was \$78.23. Bob motioned to accept treasurer's report as presented and pay bills, Jennifer 2<sup>nd</sup>, passed.
- ♦ Public Comment:
  - ★ Jeremy: August 9 & 10 2024 he plans to have an event, and he needs to know the process and timing for what he must have for the township. Things to be complete at least a few weeks before the event. No insurance needed until an approval is obtained.
  - \* Clint: gave an estimate he obtained for brining. It will be considered at the time for scheduling.
- ♦ Bob: Zoning report:
  - Status of citation mentioned at last meeting: Bob talked to Ryan Coffee and the attorney, and John also contacted them. It is a slow process. The best course is to have the attorney write a formal letter to Jeremy explaining what did happen and will happen. If in violation it will be brought to the magistrate, where it will be Jeremy and the Zoning Administrator. If Jeremy doesn't like the outcome, he can have a Circuit Court hearing with attorneys. With such a letter there could be an order to cease and desist if he is in violation. The attorney sent an ordinance from another township to review, it was given to Planning. Our violation fees are low, they would not cover expenses, it is suggested that they be reviewed. Ryan Coffee suggested to shorten up the 60-day deadline. Ryan is willing to attend meetings to work through the ordinance for this area.
