NEW BUSINESS

Alderman Hill made a motion to approve the Omnibus Consent Agenda consisting of the December 20, 2017 City Council Meeting Minutes and the Warrant (\$14,776.37). Alderman Riddle seconded the motion. Chief Miller announced an Active Intruder Seminar to take place at First Baptist Church Saturday January 13, 2018.


