**Corporate Membership Program**

The Corporate Membership Program is an attractive perk for businesses to reward their employees by giving them the opportunity to use the Club facilities. Business owners and managers will discover this is a great way to meet other business owners, develop personal and professional relationships, and have an extraordinary venue for meetings and socializing.

The primary member representing your company will be a voting “Stock” member at the current stock member price with all the rights, privileges, and responsibilities of stock membership. Stock members, their spouse and children living at home until age 22 have use of all RCC facilities, and unlimited golf under your membership. The avid golfer is encouraged to speak with the proshop manager for additional golf services available at Riverside Country Club. Additionally, you have a charge account for food, beverages, and proshop merchandise, which will be included in your monthly statement. Like all members, there is a modest monthly food and beverage purchase minimum.

Your company can have up to four (4) employees designated as “Corporate Employee” members. The “Corporate Employees” must be an actual employee of the company and cannot be customers, contractor working for company, consultants, friends etc. This means each Corporate Member will submit to RCC an ES903A Form (Employers Quarterly Wage Contribution Report) with all reference to social security numbers and wage information blacked out thus verifying company employment. The Corporate Employees designated as members can be changed on a quarterly basis (January, April, July, and October). A new ES903A must be submitted with change to or addition of Corporate Employees.

This level of membership allows “Corporate Employees” the use of the club facilities without the golf package. Your employees will receive discounted greens fees and cart use. A charge account with will not be included in this program. Cash or credit card will be required for all added expenditures at the club such as green fees, golf cart use, food and drinks, and Pro-Shop purchases. The monthly food and beverage purchase minimum is waived for everyone else in your organization.

The initiation fee is \$1000.00 for Corporate Member applicants; due upon approval.

The Corporate Membership, as with all member programs, will be reviewed, revised if necessary, and approved by the Board of Directors annually.

The Corporate Membership fee of \$350.00 per month includes one (1) Stock member and their spouse. Up to four (4) “Corporate Employee” memberships at \$100.00 each per month. Each additional “Corporate Employee” member is \$200.00 each per month.

Complete the attached application and return to Riverside Country Club and begin enjoying all the benefits of RCC membership.
