### The 28th annual Letter Carriers' Stamp Out Hunger® Food Drive is on Saturday, May 9, 2020.

Letter Carriers have a unique perspective. We not only have the neighborhoods we live in, we are part of another community – where we deliver mail. It is usually difficult not to develop some compassion for the acquaintances we make in either area.

Every day on our routes, many letter carriers see the struggles our patrons have with providing for their basic needs. It is an honor to be able to contribute to the families and the communities we serve by helping our neighbors who face hunger.

Hunger affects about 1 in 6 people around the country, including millions of children, senior citizens and military veterans. The Stamp Out Hunger® Food Drive is the country's largest single-day food drive. It is held annually on the second Saturday in May in 10,000 cities and towns in all 50 states, the District of Columbia, Puerto Rico, the Virgin Islands and Guam.

The plan is simple. Customers simply leave their donation of nonperishable goods in bags next to their mailbox before the delivery of the mail that day.

The nation's letter carriers collect the food donations and distribute them

to local food agencies. Our Branch, the West Coast Florida Letter Carriers Branch 1477 are partners with over 20 Food Banks and Pantries. These partners help collect and sort the donations and in some areas of the branch, also collect from mailboxes.

The timing is important, with food banks, pantries and shelters running low on donations from the winter holidays and with summer looming, when most school meal programs are suspended.

Several national partners assisted the NALC in this year's food drive: the U.S. Postal Service, the United Food & Commercial Workers International Union, the National Rural Letter Carriers' Association, United Way Worldwide, the AFL-CIO, Valpak and Valassis. In Florida we have Farm Share helping by donating and printing the Stamp Out Hunger bags that we will distribute and deliver in the weeks to come.

Since it began in 1993, Branch 1477 has collected over 2,215,744.00 pounds of food to stock our local pantries and banks, but the need keeps growing. What used to last 4 months to distribute to the communities has been depleted in as little as 6 weeks in some communities. We have finished #1 in our category based on branch size 9 times and topped all collections in the nation twice.

With all these years under our belts you would think the discussion of the Food Drive wouldn't be such a surprise to customers. Annually we get a number of questions asked. Here are a couple of the frequently asked questions and answers:

I put food out and it wasn't picked up. Why not? Letter carriers try to touch every single mailbox in America during the Food Drive, but the fact is that we do admittedly miss some. Please note, though, that participation is strictly voluntary, and as no system is perfect, oversights will occur. If your donation is not picked up, contact your local post office or simply place your donation by your mailbox on Monday instead. (Letter carriers will be picking up missed donations on Monday, too.) And of course, your local food banks and pantries will gratefully accept your donation in person. In any case, we are deeply thankful for your generosity and are truly sorry for any inconvenience.

I hear that some people got special Food Drive bags in the mail, but I didn't get one. What gives? A number of letter carrier locals have entered partnerships with sponsors to provide specially marked "Food Drive" bags that get mailed to customers. These sponsorships help defray the

costs associated with making the bags and mailing them. Plus, some sponsors have also backed bag distributions as well in certain regions of the country. Bag distribution isn't national—at least not yet. And you can always use your own bags or boxes. As mentioned earlier, locally Farm Share, a Florida Non — Profit organization has donated 8 million bags for distribution throughout the state with postage affixed to ensure delivery.

Unfortunately, there is always a battle with apathy. I do not get It, but we all know it exists. Please let your Steward know if you notice someone does not want to participate. We have volunteers to help on Drive Day. Bags on the other hand have postage and have the same delivery standards as any other piece of mail. This is a NALC event, one that couldn't be a success without the support of USPS. I ask only that if you want help on Drive Day let someone know. Please do not force the Stewards and Officers to defend you in discipline when mail matter is not delivered. It's our duty to represent you and we will of course...please just deliver the bags and cards.

On the other hand, the issue we sometimes face is that the support of the local Postmaster isn't always emphasized when the local Supervisor is trying to make their numbers at any cost. Annually calls come to the Hall on Friday advising us that the supervisor has disallowed bag delivery. This year, if there is push back on bag delivery, we ask you call the hall daily. Finding out on Friday makes it impossible to ensure that the time to deliver them is allowed - when it counts! Please help us make sure the bags and cards are delivered.

This year around April 10-12, the local branches in Lakeland, Tampa and Clearwater will join our volunteers in preparing the shipment of Food Drive Bags and Cards for each delivery unit. These bags will be available for delivery the week of May 4, 2020.

I urge each of you to do your part in making this year's Food Drive a success on your route. If we all do, we will break records.



### **Hubble's Troubles**

### you're on candid camera....

Surveillance cameras are installed almost everywhere today and as a result, the average American has their image recorded by dozens of cameras every day. Some have even estimated that on average, any one person who lives in an urban environment is recorded as much as 50 time a day, and that number will continue to grow. "We are heading toward a total surveillance society in which your every move, your every transaction, is duly registered and recorded by some computer," says Jay Stanley, a privacy expert with the American Civil Liberties Union.

The technology advancements in surveillance cameras have come a long way. For just \$99.00 per unit, a homeowner and/or renter can install a WI FI doorbell camera with High Definition. Even if someone doesn't press the doorbell, motion sensors can send notifications and record video of events from the street to the doorstep. It is naive to think that you or I won't be recorded at some point in the day while delivering our routes. You would think the presence of cameras persuades people to be on their best behavior, knowing that your every move may be captured on video. Video is some of the most damaging and compelling evidence. After all, what's better than catching someone in the act? This can catch the guilty but also exonerate the innocent, because the replay puts your actions in perspective.

With that said, we've all had the chance of viewing videos posted of delivery drivers throwing parcels or an unattended vehicle driving away without a driver. But what you don't see or hear about is what happened to those who were videotaped. If they were employed by the USPS, they most likely were handed an Emergency Placement and/or Removal Letters that began with:

"The video shows the Grievant..." What did the video show, are they guilty or innocent? The difference of opinion may be more semantic, according to both parties involved. Regardless of how it may be interpreted, no one wants that fifteen minutes of fame.

Pressure by a supervisor to be back at a certain time is not an excuse for taking short cuts. Instead, this inappropriate behavior destroys the character of our workplace, our es spirit de corps and our ability to engage our customers. The pressure and intimidation only leads to employees making bad choices. The anxiety that they have leads to fingering mail while driving or while walking up or down steps or while crossing the street, just to save some time. They don't take the extra time to fasten and unfasten their seatbelts or close the driver's door to save a few minutes, and they leave the engine running to jump for a parcel!

If you are being pressured and/or intimated by your supervisor's instructions to accomplish all the work assigned to you and be back at a certain time, it's important to stay calm and not argue with the supervisor. You should always fill out PS Form 3996 when you believe the route you were assigned to carry has more work than you can complete within eight hours or you believe you cannot complete all of the work assigned to you for the day within your scheduled time.

You will use PS Form 1571 when mail assigned to your route is not delivered for any reason. It could be mail your manager or supervisor instructed you to leave in the office or mail you were unable to deliver on the street and instructed to bring back. If you did not deliver the mail, then the reason, amount, and type must be recorded on this form. Lastly, inform your local NALC representative about the situation so it can be elevated and a grievance initiated.

# F M L A Family and Medical Leave Act

Is your FMLA being denied? If you wonder why, make sure you check any mail you receive from that comes from FMLA so you can meet the deadlines required and won't be disqualified from receiving the benefits you are eligible for. Many carriers don't know they don't have to call in sick in order to receive FMLA. If you are denied you should always find out why, it is usually something so simple such as how many occurrences per month you are having, then you can get an extension to get the help you need.

Regular Carriers and CCAs can qualify for FMLA protected leave if they have worked for the Postal Service for at least 12 months total or 1,250 work hours that do not have to be done consecutively. One very important thing many people don't know is that they need to know is which leave they are choosing since it's **YOUR CHOICE** to use *Annual Leave, Sick or Leave Without Pay which are all FMLA related.* FMLA can be used for doctors' appointments related to your condition and FMLA also guarantees any eligible letter carriers up to 26 weeks of leave in a single 12-month period to care for a covered service member and qualified related family members with a serious injury or illness such as their spouse, son, daughter, parent, or next of kin.

In the **ELM Section 515 (Chapter 510)** - USPS Employee and Labor Relations Manual contains all regulations covering FMLA rights as well as the Department of Labor, both valuable resources in making sure that you get the benefits you and your family may need.

Retiree Update

When you retire, I urge you to continue your NALC membership. To do so, you only need to complete a PS Form 1189. Dues for retirees are considerably less than dues for active members. For retirees of Br1477, the dues are only \$1.91 per month (\$22.90 yearly). NALC retirees are treated uniquely compared to retirees of other labor

unions. Most labor unions don't allow their retirees to serve as officers or delegates to their conventions or to participate in the operation of their locals. NALC retirees have all the rights of active members with the only exceptions being they cannot vote on ratification of National Agreements or Local Memorandums or proposed work stoppages. They can run for and serve as delegates to State and National Conventions. They can also serve as Branch, State and/or National Officers and they can participate and have a voice in the operation of their Branch.

Additionally, all members, both active and retired or Branch 1477 are entitled to reimbursement each year of (up to \$60 for self and \$50 for spouse) for out-of-pocket expenses for eye examinations or purchase of eyeglasses. As a retiree, you will continue to receive the NALC's monthly publication, "The Postal Record" and Branch 1477's monthly publication "The Twig Of The Branch". Also Branch 1477 is available to assist retired members concerning possible changes to their retirement due to personal changes, i.e. divorce, death of spouse, remarriage, etc. We also provide assistance to your survivors in the event of your passing.

### **Presidents Report:**

This coming Saturday we will be able to link up with E-Comp about injuries on the job. You still have to report accidents to your Supervisor but you can go online and file your own CA-7.directly to OWCP.

I will help you to get set up with this process and it should speed up things.

Still have a couple of Emergency placements out there, couple of removals. In Dunedin we had an emergency placement with a carrier who drove through an intersection with her door open.

Ellenton made the list where mail was discovered discarded in a mailroom over a 2 year period. The carrier was listed to be converted on March 14. He has since resigned.

In Port Charlotte we have a case where a CCA on OWCP waiting for surgery approval was sent a letter stating she wasn't being returned after her break in service. This is at Step B process now.

Amazon is cutting 1300 jobs in Florida. This will impact the USPS as the once handled parcels will be turned back over to the Post Office.

Labor Management Meeting with St. Petersburg we discussed the 3<sup>rd</sup> week in a row 20 hub routes were staffed for and they had 25,000 packages. And this Sunday I was told they plan 21.

The Rogue Nation was created on a principle by a handful of like minded individuals looking for a little Revolution that started in Oregon. Today they have grown to over 270,000 citizens.

They basically enter State and Federal Buildings and stick a camera in worker's faces and hope for a reaction. This has happened all over the Suncoast, please remind everyone not to engage these individuals.

The Census is getting ready to start this week so be aware. This is the single largest mailing in U.S. history.

May 9 is the 28<sup>th</sup> Annual Food Drive and have about 8 million bags to distribute in the State of Florida. Farm Share is picking up the expense of these bags.

March 11, we received information from National concerning COVID-19 Corona Virus. Several events have been cancelled within our Union. The AFL-CIO postponed the executive council meeting and presidential forum scheduled for the week of March 9.

The NALC postponed a dinner to celebrate the 50<sup>th</sup> Anniversary of the Great Postal Strike scheduled for March 21, 2020.

The Committee of Presidents scheduled for April in Anchorage, Alaska and in St. Petersburg in September has been postponed.

### Director of Insurance, Health and Mutual Benefits Representative

### **MBA NEWS**

I received a letter from Jim Yates MBA Director, life Insurance. Introducing three (3) new insurance plans being offered to the NALC membership. The insurance plans Term Life Insurance policies, which offer affordable protection over a certain period of time.

The new Term Life Insurance policies include: 20 Year Term Life, Term to Age 65, and 5 Year renewable and Convertible Term life. The plans are available to the NALC member, spouse, children, stepchildren, grandchildren, step grandchildren, great grandchildren, and even the parents of the NALC member. The proposed insured must be between the ages of 17 and 60. The Face Value (Death Benefit) for each insured may be any amount from \$10,000 to \$100,000.

The 20-year Term Life plan offers insurance protection for a period of 20 years. The premium rate is based on the current age of the proposed insured and the amount of life insurance applied for. The premium rate will never increase for the 20 year period. A long as the premiums are paid on the policy, the insured is guaranteed life insurance for a period of 20 years.

The Term to Age 65 plan offers insurance protection until the insured reaches age 65. Regardless of the issue age the insured, the policy will remain in force until the policy anniversary date the insured reaches 65. Like the 20 Year Term, the premium rate is based on the current age of the proposed insured and the amount of insurance desired. In addition, the premium rate will never increase during the lifetime of the policy. This plan of term insurance is especially valuable to those individuals who will not need additional insurance during their retirement years.

The 5 Year renewable and Convertible Term Life plan provides insurance protection for a period of 5 years. As with the two plans above, the premium rate is determined by the proposed

insured's age and the amount of coverage. After each 5 year period, the policy owner may choose to renew the term policy for an additional 5 year period or convert the policy to a whole life insurance policy. The insured may choose to either option without

providing evidence of insurability or taking a medical exam. The premium rate at the time of renewal or conversion will be at the insured's current age (generally the premiums will increase). The policy is convertible until age 65 and renewable until age 80.

These new Term Life Insurance plans are especially attractive to City Carrier Assistants (CCAs) who are not eligible to obtain the federal Employees Group Life Insurance (FEGLI). These plans allow the CCAs to provide life insurance protection for their families at a reasonable cost well into the future.

The MBA will have an insert in the April 2020 edition of The Postal Record introducing these new Term insurance plans to the membership. In addition to a description of each plan, an application for insurance will be provided.


