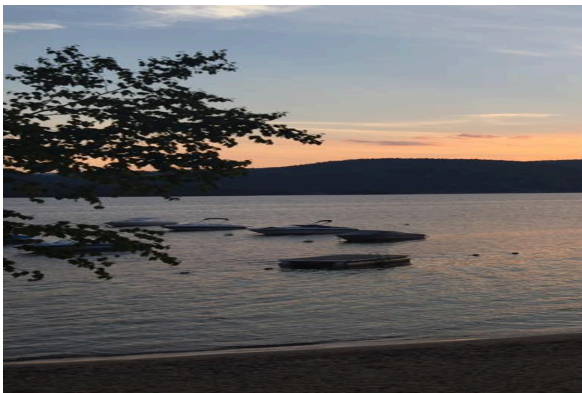

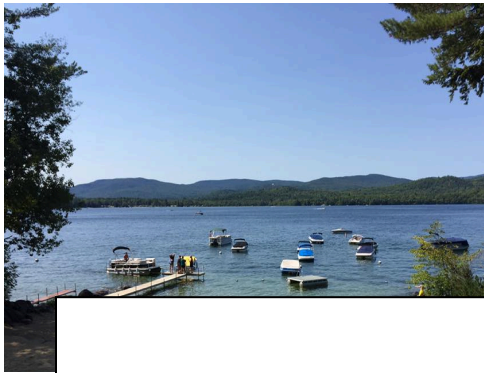

WIA MOORING POLICIES

UPDATED WIA MOORING POLICIES. PLEASE READ! All those members who currently have use of a mooring must comply with these regulations or risk losing their mooring permit.

IMPORTANT

1) Send your annual mooring fee of \$175 (along with your WIA Membership Dues) to Diane Farraher-Smith, 63 Walden Pond Ave., Saugus, MA 01906 on or before April 15, 2017. Send a copy of your boat decals & a copy of your boat insurance not less than \$100,000 to Tony Bonaccorsi, 127 Dix Street, Bridgewater, NH 03222

WIA MEMBERSHIP

Annual dues is predetermined at a set rate per family. To assist with accommodating all WIA members who would like a canoe/kayak spot – for the 2017 season, there will be a limit of one spot per family/household. Waterfront property owners can contribute a “good faith” donation of \$30.00 toward beach improvements.

If you are not a member of the WIA, please help maintain your beach by joining. Only paid WIA members and their guests may use the parking lot, dock, raft, beach storage shed and any other equipment.

2) Those boat owners wishing to be on the “Temporary Mooring List” (who may be assigned a mooring temporarily based upon a vacancy) should also send a copy of their boat decals and boat insurance to Tony Bonaccorsi as above.

IMPORTANT: There is **NO GRACE PERIOD**. If you wish to remain a mooring holder or on the mooring waiting list, you must be a WIA Member in good standing and pay ALL your dues and fees ON TIME. Those who do not pay their dues on time will be removed from the mooring ball and/or from the mooring waiting list.

Mooring regulations require that for those who wish to remain on the mooring list, their dues **MUST BE PAID** by **June 20, 2017** otherwise your name will be removed from the waiting list and will not be reinstated until your dues is paid. Additionally, your name goes to the bottom of the waiting list. If any current permit holder decides to forfeit their permit, they must notify the WIA so that the mooring can be offered to the next member on the waiting list. Mooring expenses are borne entirely by the permit holders (rate is currently \$175.00 per year), and the mooring fund make an annual contribution of \$300.00 to the WIA general fund. To be placed on the waiting list, or if you have questions regarding mooring, contact one of the association officers. The public boat ramp at Wellington State Park provides an alternative site for our association members to have access to the lake for their boats, if they are not able to use our association mooring field. There is no charge for launching boats at the ramp, and it is wide and easy to access.

To be added to the Temporary Use Mooring List:

In the event that a mooring becomes available for temporary use, and in order to reduce the time needed to assign a temporary mooring to a suitable boater, it is requested that all persons on the mooring list who are interested in a temporary mooring, if one should become available, you should provide the items listed below to the Mooring Coordinator on or before June 20th. In addition to all other regulations herein, the user of a temporary mooring shall pay a fee of \$40.00 to the Treasurer to be deposited into the mooring account, for each separate use of a mooring during the boating season.

1. Copy of boat decals
2. Copy of proof of insurance (no less than \$100,000)
