

Enclosed is important information that you will need to begin preparing for the District Convention on June 3 & 4, 2018. A good time to take care of this business would be at your fall voters' meeting or at the annual meeting of your congregation. *Please pay close attention to the return addresses for each item, as they are different.*

Convention Fee

The cost for the 2018 District Convention is \$270/per congregation; you will be invoiced at a later date.

Official Nominating Ballots

Enclosed are ballots for <u>District President</u> and <u>Vice President</u> (lists of available pastors by Region have also been included), <u>Voting Delegates (A)</u>, and <u>Advisory Delegates (B)</u>.

- 1. Complete <u>all</u> information on the official nominating ballots.
- 2. Have your congregational president and secretary <u>sign</u> the ballots. Unsigned ballots will not be accepted.
- Mail all ballots as noted below <u>by February 2, 2018</u>. Be sure to allow two to three days for mail service.

Advisory Delegates

Advisory Delegates are <u>required</u> in the Bylaws to attend the District Convention unless they have sent in a request to be excused. Each Delegate should complete the attached <u>Convention Payment</u> form if they wish to partake in the convention and submit the required fee, if applicable. If the Advisory is not able to attend, a separate letter of excuse should be submitted.

Other Attendees

Others are invited to attend the convention, however, each attendee will need to complete the attached **<u>Convention Payment</u>** form if they wish to partake in the convention and submit the required fee, if applicable.

Circuit Visitor Nominating Ballots

Also enclosed is the official nominating ballot for Circuit Visitor.
