- No training of any kind in the ring. Bring your own water.

DOS entries are 7:00 – 7:30 A.M. each day (provided trial is not full)

Entries must be received by July 6th, 2024 at the secretary's address.

\$15.00 same dog same trial pre-entry only. Pre entry Junior \$10.00,

After closing date, entries are \$30.00.

Entries will run in "B" if no designation is indicated. It is exhibitors' responsibility to mark entry if requesting to jump minimum height in obedience.
