Meeting was called to order at 7:01pm by Commissioner Nanninga.

Pledge of Allegiance was led by Commissioner Baltazor.

Public Comment: No member of the public requested to speak.

### **Action items**

**ITEM 4**: *Approve minutes of prior meeting(s).* 

Motion to approve minutes of the regular meeting held May 21, 2020 as presented.

Motion: Hunsberger Second: Baltazor [Unanimous]

ITEM 5: Review bookkeeper's report from Municipal Accounts & Consulting and consent to: a) approval of payment of monthly bills and invoices, b) approval of monthly financial report.

Wilson presented the District's monthly financial statements, monthly bills, and invoices. The District's credit card company had charged a late payment fee, but Wilson said the company has agreed to reverse that charge as their billing had been delayed. Commissioners again raised concerns with MAC regarding the large amount of District funds earning a low interest rate in the Texpool account. MAC was instructed to invest a more substantial amount of District funds in laddered certificates of deposit rather than keeping the funds liquid while waiting to see if interest rates rise.

Motion to approve reports as presented.

ITEM 6: Discuss and take action relative to District Capitalization Schedules

Commissioners discussed having MAC provide the District with a regular Capitalization Schedule rather than continuing to have the auditor include it in with their annual background material. MAC will require a contract be signed with the District and will charge an annual fee of between \$1000 to \$1500.

Motion to authorize President Nanninga to sign a contract with MAC for MAC to provide the District an annual Capitalization Schedule and include that schedule in their monthly reports to the District.

ITEM 7: Discuss and take action Relative to 2021 Budget

Wilson presented a draft budget for fiscal year 2021. Commissioners compared it to the fiscal year 2020 budget and discussed adjustments that may need to be made. SBFD will be able to present their budget request to the District within a couple of months. Budget discussions will continue at future meetings.

ITEM 8: *Discuss, take any action relative to Local Sales and Use Tax*No action taken.

ITEM 9: Receive monthly report from Sam Bass Fire Department regarding operations, including but not limited to: A) Total number of calls, B) Training, C) Fire Marshall Activities, D) Breakdown of activities and E) Information of any major incidents.

Chief Kieschnick presented incident report data for May, 2020. It should be possible to include maps showing incident locations again next month. SBFD has experienced reduced call volume during the COVID-19 pandemic.

ITEM 10: *Discuss and take any action relative to operations, as may be needed following above report.*No action needed.

ITEM 11: Discuss potential agenda items, time and date for future business meetings. (07/16/2020).
