## Program Description

The **Health Occupations I** program will provide students with the basic theory and clinical experience for entry-level positions in a physician's office, hospital or outpatient clinic. Students will participate in classroom learning consisting of both theory and hands-on demonstrations and practice as well as have the opportunity to participate in internships/job shadow experiences with local health care professionals. The curriculum provided allows students to explore their interest in many fields within the medical profession, including but not limited to: nursing, medicine, advanced practice nursing, physician's assistant, laboratory science, emergency, medical terminology, radiology, surgical technology, and nuclear medicine.

**Health Occupations II (Pharmacy Technician)** program prepares students for employment in hospital and retail pharmacies, as well as for post-secondary careers in Health Science. Pharmacy Technicians assist licensed pharmacists in providing medication and services under the supervision of a pharmacist. This program also prepares students to take the National Pharmacy Technician Exam and meets the state CTE program requirements. The Pharmacy Technician program offers work-based learning experience, which gives practical experience in the field of Pharmacy.
