## Bay County Fair and Youth Exposition 2016 Camping Rules

- 1. Camp sites will be assigned by the Bay County Fairboard. Campers may camp in designated camping areas only. Anyone using more space than assigned will be asked to reduce the amount of space they are using, or will be asked to leave the camping area.
- 2. All persons camping are required to have an adult camping at the assigned site who will assume responsibility for their conduct. **The adult must spend the entire night at the site**. (*Regardless of 4-H member's age, the adult at the site must be a parent or guardian.*) The names of these adults and all names of the campers must be listed on the Camping Application. All campers and guests who stay at the campsite must be reported to the Fairboard Office or they will be asked to leave.
- 3. No vehicle traffic will be permitted in camping areas or down the Midway area from Tuesday, August 9 through Saturday, August 13 between 10:00 a.m. and 12:00 am midnight.
- 4. No bikes, skateboards, push scooters, roller blades, four-wheelers, golf carts or motorized vehicles are permitted on the fairgrounds unless pre-authorized by the Bay County Fair Board at least one week prior to fair. - 5. No horses are allowed in camping areas or on the rail trail at any time.
- 6. Pets must be on a short leash (less than 8 feet long) or in a crate. Owners will be asked to remove aggressive, vicious, obnoxious, or barking dogs from the fairgrounds. Must be licensed, and all shots up to date.
- 7. No livestock animals may be housed at campers at any time.
- 8. Adult Campers (at least 21 years old) may possess/consume alcoholic beverages at their campsite only. Those renting sites are responsible for any illegal activity or other actions deemed unsuitable by the Bay County Fairboard. This will result in loss of the camping site and you will be asked to vacate the grounds immediately.
- 9. No open flames (campfires, fire pits, candles, etc.) allowed at campsites. There will be a community campfire pit near the Livestock Arena.
- 10. Camping areas must be clean at all times. Trash pick-up is the responsibility of the camper.
- 11. Picnic tables are not provided for campers. Campers may bring their own.
- 12. Quiet hours are from 11:00 pm to 6:00 am. Please be respectful of your neighbors.
- 13. Campers may set up their sites on Saturday, August 6 or Sunday, August 7, and may not leave before Sunday, August 14 at 7:00 a.m.
- 14. All campers are to abide by these camping rules. Persons not following these guidelines may be asked to leave the camping area with no refund.
- 15. Late entries will be assigned only if space is available.
