Tia Quick has been a Deputy District Attorney for over 25 years and is currently assigned as the Law Enforcement Liaison to the San Diego Police Department and nine other agencies. She works specifically on Informant issues, search warrants, arrest warrant and advises on legal questions.

She served in the Major Narcotics Unit and Gang unit during her time as a DDA.

Ms. Quick will speak about the current state and readiness of law enforcement in San Diego County and will bring information about the issues of de-funding and weakening government support for the police in San Diego and in California. She will discuss and give her take on such issues as:

Prop B - on the ballot in San Diego City setting up a new Commission on Police Practices to oversee all police "misconduct" and give recommendations for discipline of officers.

State Prop 20 – proposes to weaken some of Prop 47 's rules that made many crimes only misdemeanors. This is good...

State Prop 25 – which threatens the cash bail system

CA Senate Bill SB731 – seeks to eliminate all immunity for police officers. This commission can revoke the licenses of police officers who they feel commit misconduct and prevent them from being re-hired by any other police department.

Law Enforcement is up against it this year. They need our support and our actions to help them. Tia Quick is well-acquainted with law enforcement and the legal issues facing San Diego County and California. We look forward to hearing her suggestions on what we can do to help re: these important issues.
