Present at the meeting were Councilman Darren Janesky, Councilwoman Janie Wilson, Councilman Dennis Stroupe, Councilman Mike Patterson with Mayor David Hogue presiding.

Scott Powell with the Gaffney Ledger represented the media.

The invocation was given by Mayor Hogue.

Councilman Patterson made the motion to approve minutes as written and distributed. Councilwoman Wilson seconded the motion. All were in favor.

Councilman Patterson made the motion to approve the bills. Councilman Janesky made the second. All were in favor.

Administrator Carter made a request for funds for safety improvements at the two ballfields. The request came from the Cherokee County Recreation Board. The being no further business, Councilman Patterson made the motion to adjourn and Councilman Wilson seconded the motion. All were in favor.
