- On a motion duly made by S. Johnson, seconded by S. Matto, through unanimous vote, the board approved donation of 20 feet of HOA's erosion control fabric for Christ the Good Shepherd non-profit community garden.
- On a motion duly made by P. Marshall, seconded by S. Johnson, through unanimous vote, the board approved Lake Forest Utility District "Consent for Encroachment" for phases 2b and 3 of Grant Road Wall Project.
- On a motion duly made by S. Johnson, seconded by B. Bowen, through unanimous vote, the board approved repairing all irrigation beginning at N. Eldridge/Grant Rd. running north to New Hampton Drive for a cost not to exceed \$ 12K without additional review.
- Update given on Grant Road Wall Project indicating phase 2b wrapping up and demo for phase 3 expected to start week of September 21st.
- Board notified following issues deferred to October meeting due to limited time: 10 year tree plan, design plan from Pearce Scapes for beautification plan for common area pond in Gardens of Lakewood Forest, public inquiry to Judge Hidalgo regarding issues related to Hurricane Harvey.
