**APPROVING THE HIRING OF MICHAEL COMLEY-DALTON AS A FULL-TIME
EMPLOYEE AND TROY GEARHART AS A PART-TIME EMPLOYEE IN THE ROAD
DEPARTMENT**

The Board of Trustees of Jefferson Township, Montgomery County, Ohio met in regular meeting on the 20th day of June 2017 at 7:00 P.M. at the Township Offices located at One Business Park Drive, Dayton, Ohio with the following members present:

Trustee _____ moved for the adoption of the following resolution:

WHEREAS, The Jefferson Township Trustees previously agreed to advertise for and select an additional ~~part-time~~ employee in the Jefferson Township Road Department; and

WHEREAS, The Township Administrator and Code Enforcement Officer reviewed a number of applications and interviewed several candidates: and

WHEREAS, Based on qualifications and previous experience it is the recommendation of the Township Administrator and Code Enforcement Officer that Michael Comley-Dalton be hired as a full-time employee in the Road Department with a compensation package of \$14.00 per hour as both an OPERS Exempt Position and W2 employee; and Troy Gearhart be hired as a part-time employee in the Road Department with a compensation package of \$16.75 per hour as both a OPERS Non-Exempt Position and W2 employee;

WHEREAS, it is in the best interest of the Jefferson Township Road Department to have reliable staffing for the health, safety, and welfare of the Township Roads and Cemeteries for the public.

NOW, THEREFORE, BE IT RESOLVED, that the Jefferson Township Board of Trustees approve the recommendation that Michael Comley-Dalton be hired as a full-time, and Troy Gearhart be hired as a part-time employee in the Road Department. This position shall be classified as a road crew members. The terms of employment will be determined by the Board of Trustees of Jefferson Township, Montgomery County, Ohio.
