



Thank you for your interest in the 2025 Nautical Flea Market being held on **January 18-19, 2025**. This is the **35<sup>th</sup> year** that the Cities of Lighthouse Point and Pompano Beach have joined together to hold this successful community event located in Community Park (820 NE 18<sup>th</sup> Avenue, on Federal Highway between NE 6<sup>th</sup> & 10<sup>th</sup> Streets in Pompano Beach, FL)

To complete your application and secure your space:

1. Review vendor map at [www.nauticalfleamarket.com](http://www.nauticalfleamarket.com).
2. Vendors must sell marine or nautical related goods. We reserve the right to restrict the type & number of vendors, and to select vendors who best meet the needs of the event. Land spaces (on grass) are approximately 200 square feet. Boat spaces are approximately 15' x 25' and **MUST contain a minimum of 75% boats**; remaining space may be boat parts, motors, trailers, etc. **This will be strictly enforced and you will be asked to leave if not in compliance.**
3. Complete and sign the Vendor Application (all pages).
4. We are required by the state to collect 7% sales tax.
5. Check or Money Order payable to City of Pompano Beach. Visa and Mastercard accepted in person only at the below address.

**If you arrive prior to your scheduled time, you will be asked to return later in the day so we can ensure all vendors can access their spots.**

Saturday, January 18<sup>th</sup> - vendor access: 6:00 am / public access: 8:00 am to 5:00 pm

Sunday, January 19<sup>th</sup> - vendor access: 6:00 am / public access: 9:00 am to 3:00 pm

**Vendor Spaces:** *Land Spaces-* approximately 200 square ft. for merchandise

*Boat Spaces (75% boats, 25% miscellaneous goods)- 15' x 25*

All merchandise, trailers, vehicles, etc. **must fit** within your allotted space. If for any reason your “stuff” does not fit within your space, you will be required to purchase additional spaces. Due to the layout of the park & its curved walkways, spaces may not be “square” and may be adjacent to another vendor. **Security:** Law Enforcement Detail will be on site (including overnight) beginning Friday, January 17<sup>th</sup> until Sunday, January 19<sup>th</sup>.

**Vehicles/Parking:** Vehicles brought in on Friday for load-in and parked within the Event Site will not be allowed to leave until gates are opened on Sunday, January 19<sup>th</sup> at 3:30 pm. All other vehicles owned by Vendor, its employees, etc. shall be parked in the designated vendor parking areas in order to provide unobstructed driveways for emergency vehicles.

*\*Note: You may drive in with your vehicle to set up but all vehicles must either be removed from the park on Friday, January 17<sup>th</sup> by **4:00 pm** or remain until the close of the show on Sunday, January 19<sup>th</sup> at 3:30 pm. You can walk to your booth anytime on Friday from 7:00 am to 5:00 pm; or from 6:00 am on Saturday and Sunday. No vehicles are allowed after 5:00 pm on Friday as the Fire Department locks the gates. Load out begins at 3:30 pm on Sunday, January 19<sup>th</sup>.*

If utilizing a tent company, please note your tent must be installed on Thursday, January 16<sup>th</sup> between 12:00 pm and 4:00 pm. Merchandise cannot be placed in your space until Friday, January 17<sup>th</sup> during your assigned load in time.

#### **Rules and Regulations:**

1. Only those products directly related to the design, construction, repair, maintenance and/or use of recreational boats and the marine industry shall be displayed by Vendor. Vendor shall remove items and/or displays not in compliance with this application.
2. Electricity, water and telephone services are not available within the Nautical Flea Market. Due to fire regulations, generators are not permitted (inverters are ok).
3. **RELEASE & INDEMNIFICATION AGREEMENT:** The undersigned in consideration of the Nautical Flea Market and the Cities of Pompano Beach and Lighthouse Point providing us with space for sale of our various nautical goods, and other valuable consideration, do hereby release the Nautical Flea Market, the Cities of Pompano Beach and Lighthouse Point, and any other of their members, employees, agents, or volunteers from any liability for the loss or damage of work, personal injuries or property damage. Further in consideration of the above, the undersigned does hold harmless and agree to indemnify the Nautical Flea Market, the Cities of Pompano Beach and Lighthouse Point and any of their members, employees, agents, or volunteers for any damages, attorney fees, or costs for any legal actions resulting from any claim made in which they, their members, employees, agents, or volunteers are made parties defendant. The release and indemnification agreement applies for the duration of the Nautical Flea Market scheduled for the 17<sup>th</sup> through the 19<sup>th</sup> day of January 2025, and to any claims made within the application statute of limitations for loss occurring during that period of time.
4. NO pets are permitted in the Nautical Flea Market.

5. Nautical Flea Market Event is a rain or shine event. No refunds will be given.
6. Clean Up: Vendor is obligated to clean up their allocated space and remove any and all articles placed on the ground, waste products, merchandise and debris from such area. No holes may be made in the asphalt for tent poles. Oil and fuel containers must be disposed of properly. No pressure cleaning is permitted. Vendors must vacate space by 6 pm on Sunday, January 19<sup>th</sup>. Event Committee reserves the right to charge a cleaning fee to vendors that do not comply.
7. All food & beverage sales are handled exclusively by PCI. No vendor may sell or give away any food or beverage items without prior written consent by the Event Committee.
8. Vendors & guests are not allowed to bring beer or alcoholic products; all coolers & bags are subject to inspection.
