Protecting your private information is our priority. This Statement of Privacy applies to www.RileyPress.com and Riley Press, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Riley Press, LLC include www.rileypress.com and RILEY PRESS. Collection of your Personal Information

RILEY PRESS may collect personally identifiable information, such as your name. If you purchase RILEY PRESS's products and services, we collect billing and credit card information.
