To all parties listed above:

Due to the past problems with the appearance of impropriety and apparent conflict of interest by some members of the Association, it is now necessary to promulgate [this is a draft from Attorney Wayman L. Prince], a policy statement (to be signed) by the Association upper echelon to avoid any conflicts (Board of Directors, General Counsel and Attorney):

• 1) "No Member of the Board of Directors, Officers, General Counsel or Attorney of Pine Village North Association may purchase property of Pine Village North Association at either a Foreclosure Sale, Tax Sale, Constable Sale, Judgment Sale, or any other sale which is considered an Auction of that property without there being full disclosure and a vote by the Board of Director of Pine Village North Association prior to the sale of that property";

- 2) "No Member of the Board of Directors, Officers, General Counsel or Attorney of Pine Village North Association shall have a contract for these services with Pine Village North Association, that includes, but is not limited to, any maintenance work, delivery service, repair service, plumbing, electrical, landscaping, janitorial, engineering, roofing, design, building, and any other services that may create a conflict of interest or the appearance of impropriety without there being full disclosure and a vote by Board of Directors of Pine Village North Association prior to management of such service";
- 3) "No Member of the Board of Directors, Officers, General Counsel or Attorney of Pine Village North Association shall use any undue influence, forcible persuasion of threats of reprisal to conduct business affairs and for employment of personnel at Pine Village North Association without there being full disclosure and a vote before the Board of Directors of Pine Village North Association prior to any act or conduct involving this method of transacting business";
- 4) "No Member of the Board of Directors, Officers, General Counsel or Attorney of Pine Village North Association shall use their position to allow outside persons to directly engage their services for material gain to the detriment of Pine Village North Association while that member profits or benefit form the outside person's material gain without their being full disclosure and a vote before the Board of Directors of Pine Village North Association prior to any such act"; and
- 5) No Member of the Board of Directors, Officers, General Counsel or Attorney of Pine Village North Association shall publish in written form any printed material for gain or profit to the general public while serving in their capacity without there being full disclosure and a cote before the Board of Directors of Pine Village North Association prior to any publication"; and
- 6) Finally, <u>no nepotism</u> or blood-line relationship among the Board of Directors shall be allowed by election, consent, ratification, voter approval or replacement of Board of Director Member.
