### Important Dates

- Town of Eureka – (3 At-Large Commissioner seats) – Filing Fee \$5
- Town of Fremont – (Mayor & Districts 1, 2, 3, 4, 5, & 6 seats) – Filing Fees: \$5
- Town of Mt. Olive – (Mayor, 1 At-Large Commissioner seat, & District 1, 2, 3, & 4 Commissioner seats) – Filing Fees: Mayor \$24/Commissioner \$6
- Town of Pikeville – (3 At-Large Commissioner seats) – Filing Fee \$5
- Village of Walnut Creek – (3 At-Large Councilman seats) – Filing Fee \$5
- Town of Seven Springs – (Mayor & 2 At-Large Commissioner seats) – Filing Fee \$5
- Fork Township Sanitary District – (2 Member seats) – Filing Fee \$5
- Northwestern Wayne Sanitary District – (5 Member seats) – Filing Fee \$5
- Southern Wayne Sanitary District – (3 Member seats) – Filing Fee \$5
- Southwestern Wayne Sanitary District – (All 5 Member seats) – Filing Fee \$5

### Where Do I File?

### What do I need to bring?

- Valid photo ID for notarization purposes;
- Check/money order (must include name/address pre-printed on check-exact cash accepted for fees under \$50).

### What to expect:

- If arriving on the first or last day of filing, please be prepared to wait;
- Election Officials will initially verify your eligibility to file for office;
- If qualified, filing paperwork will be completed & signed/notarized - filing fee must be paid at time of filing.

### Campaign Finance:

- Candidates have 10 days post-filing to submit *Statement of Organization* paperwork (regardless of Office sought, all filers establish a Committee & therefore must adhere to NC Campaign Finance law);
- It is recommended to use the state-provided campaign finance reporting software for all report filings;
- If you have a previous campaign committee with our office, please be sure to notify Election Official & verify all information is current and accurate.
