DEERBERRY NEIGBORHOOD IN BRODIE CREEK COMMUNITY AND MODIFYING DECLARATION OF COVENANTS AND RESTRICTIONS OF BRODIE CREEK

THIS AGREEMENT is hereoy made on the date here under set forth by agreement of the fee title owners of BRODIE CREEK pursuant to the Covenants, Conditions, Easements and Restrictions for the Deerberry Neighborhood in the Brodie Creek Community.

WITNESSETH:

WHEREAS, on or about September 26th, 2001, an agreement was made between Brodie Creek Property Owners Association, Inc. (here after "Brodie Creek") and Holeman Construction Company (here after "Holeman") under which Lots 7, 8, 9, 10, 11, 12, and 13 were replatted into lots 7R, 8R, 9R, 10R, 11R, and 12R;

Whereas, under the agreement the assessments of the original seven lots were to be pro-rated between the new six lots;

Whereas, over time the difference in the assessments as set forth in the articles of incorporation and bylaws of the Brodie Creek between these six lots and those of the other lots in Brodie Creek have grown significant;

Whereas, Brodie Creek desires to correct this growing inequity.

NOW, THEREFORE, the portion of the Agreement between Brodie Creek and Holeman prorating 7 assessments between lots 7R, 8R, 9R, 10R, 11R, and 12R is revoked and

- 1. **Henceforth** any assessment of these six lots will be calculated in the same manner as the assessments of all other Brodie Creek lots governed by Brodie Creek.
