Additionally, as an elected officer and member of the DCCW board, anyone who will be a Deanery President for the 2020-2022 term may not hold another elected position on the DCCW Board for the same term. (Bylaw Article XII, Sec.11)

To be considered please submit the attached **DCCW Officer Candidate Information Form** as directed or pass potential candidate names and contact information on to one of the Nominating Committee members listed below. The **Officer Candidate Information Form** must be completed in full and sent to the DCCW Nominating Committee Chair, Marcie Downs, **no later than June 15, 2020**. This form will be reviewed by the Nominating Committee with approved candidate forms submitted to voting members of the DCCW Board of Directors prior to voting at the July 24, 2020 DCCW Board meeting. Elected officers will be installed at the end of the DCCW Convention the weekend of July 25 – 26, 2020.
