A one hour work shop preceded official meeting.

Chairman Bernard led group in the Flag Salute.

A roll call was taken:

Motion was made by Mr. Walsh and seconded by Mrs. Hand to approve the minutes of the November meeting. All present voted in the affirmative.

Public Portion

Motion made by Mr. Walsh and seconded by Mrs. Hand to open public portion of meeting. All present voted in the affirmative. Opened at 8:00 pm.

Discussion regarding who would be best to apply for grants, the fire district or the fire department.

After conversation with the board and Chief Hand it was agreed that it became apparent that the fire department had an advantage to apply for grants.

Motion was made by Mrs. Hand and seconded by Mr. Walsh to close the public portion. All present voted in the affirmative. Closed at 8:20 pm.
