At 7:35 am there were introductions around, we welcomed Howdey Goudey KE6BEE as a guest. The meeting was officially called to order at 8:07. There were 11 present.

TREASURER'S REPORT- Audrey said there was in Checking, \$6,286.61 starting, plus \$30 dues, \$20 paid to Sate Filing leaving a balance of \$6,206.61. In savings there was \$579.46.

MEMBERSHIP REPORT – Audrey mentioned that not many are checking in on the nets, maybe 6-8 each day. Fewer on Thursdays and Tuesday evening nets. Maybe we should try to motivate more check-ins.

Suggestions of question of the day, theme of the day or saying. Suggestion also about two rounds, the first just to check in and the second to chat. Also, for net controllers to support other net controllers.

Roger KE6SZG also mentioned that if we don't use our frequencies, we will lose them.

NET CONTROLS- Due to the sparseness of this month's activities, NET participation was also very low this month.

OLD BUSINESS- Roger, Don Smith from EBARC and Allen were at the repeater tower with suggestions for the Board to consider.

Roger also mentioned he is still researching Echo link for our repeaters.

Clean-up crew needed and date for garden party to be set up soon; need 3-4 people for 2-3 hours.

NEW BUSINESS- Picnic to be second Sunday of September. Meal to be hamburgers and hot dogs and salads and beans. Crew to be set up.

Christmas party to be on second Saturday of December at El Sol Mexican restaurant. Have banquet room to hold 30-35 people.

FIREWORKS

The <u>Contra Costa County Office of the</u> <u>Sheriff</u> would like to remind all county residents about the use of fireworks during the 4th of July holiday.

Contra Costa County is a 'fireworks-free zone';

the sale, possession or use of fireworks of all

types and sizes (including Safe & Sane

fireworks) are banned in the county (County

ordinance 44-2.002). This includes the

unincorporated areas as well as the cities.

Deputy Sheriffs and officers on patrol will confiscate all fireworks.

People who have illegal fireworks for disposal can call their local police departments or the fire district's main office at 925-941-3300.

People should not take fireworks to fire stations for disposal, Broschard said.

This Fourth of July is expected to be hot, windy and dry, which means high fire danger in the county. Broschard said fireworks cause injuries and fires each year.

Last year, there were reports of more than 40 fires caused by fireworks in the fire district's service area. Those fires resulted in damage to at least one structure and one person was hurt, Broschard said.

Fire officials urge residents to enjoy fireworks by attending public displays conducted by professionals.

They also urge parents to make sure their children don't

have any fireworks and to teach them that fireworks are dangerous.

The fire district has set up a hot line that people can call to find professional fireworks displays near them. That number is 925-941-3328.
