



## 2022 FLORIDA AGRICULTURE & WILDLIFE EXPO (FAWE)STEER SHOW AND SALE RULES AND REGULATIONS



**Entry due:** September 3, 2021      **Initial weigh-in:** September 18, 2021  
**Final Weigh-in:** March 13, 2022  
**Show date:** March 14, 2022      **Showmanship:** March 14, 2022  
**Sale date:** March 15, 2022

**\*\*Exhibitors must be present for all events!**

Entry Form and *non-refundable* \$25.00 entry fee must be turned in to Mr. Ahrens, Ms. Moores, or postmarked by September 3, 2021. Entry Form is attached to the last page of these rules; **it is required that you read and understand all the following rules.** Backup Animals are allowed but MUST be registered with separate entry form - No additional entry fee required.

### 1. **INITIAL ELIGIBILITY REQUIREMENTS:**

- 1A. Exhibitors must be enrolled in a Hernando County 4-H or Hernando County FFA and be in good standing to be eligible to enter. Entrants must meet age level requirements for the program in which they are enrolled.
- 1B. Each exhibitor may show no more than one (1) steer. Exhibitors cannot show in another county fair's terminal shows.
- 1C. All exhibitors will be required to attend a mandatory educational clinic **October 7, 2021, 6:00-7:30 pm** -Hernando High School Cafeteria; exhibitors must arrive prior to 6:00 pm and remain until 7:30 pm.
- 1D. Each exhibitor is permitted to participate in up to two (2) market animal projects in the FAWE.

### 2. **INITIAL WEIGH-IN**

- 2A. Steers are required to be checked in, tattooed, ear tagged and weighed SATURDAY, SEPTEMBER 18, 2021, beginning at 7:00 am. Exhibitors/steers must be in line no later than 9:00 am. At initial weigh-in, it is **recommended** that steers weigh a minimum of 550 lbs. and a maximum of 900 lbs. The location is just off Hwy 41 on the airport grounds. The entrance will be marked and is located after the SWFTMD building but before the railroad tracks.
- 2B. All steers must be de-horned. Steers with horns more than 1 ½" in length will be disqualified. If horns grow after the initial weigh-in, they can be no longer than 1½" long at the final weigh-in. Measurement will be taken from hair line to end of horn. Scurs are permitted.
- 2C. Animals must be steers. Evidence of testicles remaining on animals castrated by bloodless techniques may result in disqualification. Failure to detect that an animal has not been steered does not qualify the animal for entry at the final weigh-in.
- 2D. Steers must **not** be over 24 months of age on/or before March 13, 2022 or they will not qualify to show.
- 2E. Exhibitors will be issued an official record book which must be completed by the exhibitor and submitted at final weigh-in (time specified later in rules).

### 3. **POST INITIAL WEIGH-IN TO FINAL ENTRY**

- 3A. The FAWE Livestock Committee would like to emphasize general care, grooming, cleaning of stalls/pens, and feeding of projects are the responsibility of the exhibitor, with assistance only from FFA Advisor, 4-H Leader, Livestock Committee, Parent/Guardian, or fellow exhibitor. Care and Feeding includes providing feed, water, hay, pails, and tie ropes, etc.
- 3B. All steers must weigh at least 900 lb. at the March 13, 2022 weigh-in.

#### 4. FINAL WEIGH-IN

- 4A. FINAL WEIGH-IN will be held on March 13, 2022 beginning at 7:00 am. YOU MUST BE IN LINE BY 9:00 am.  
 -Steers weighing more than 1350 pounds will be sold at 1350 pounds.  
 -**LIGHTWEIGHT STEERS:** Steers not meeting minimum weight requirements will be referred to as Lightweights. Lightweight steers are eligible for record book and showmanship competitions only and will be sold at the end of the auction.
- 4B. During Final Weigh-in, no equipment/tack/supplies will be unloaded until after the final steer is weighed. Exhibitors having supplies that must be removed to unload their animal will be sent to the end of the line. All equipment must be kept in their designated areas for the duration the FAWE. *Each club/chapter can only have one trailer in the designated area (an additional trailer may be allowed for those with a high number of participants but must be requested); any unauthorized vehicles will be towed at the owner's expense. If the trailer your animal is riding in is ready to be unloaded, and you are not present, your animal will go to the end of the line.*
- 4C. Health Regulations are subject to the Florida Department of Agriculture regulations in effect at the time. The FAWE Office will keep you informed of these regulations. No animal showing visible signs of illness or infestation will be accepted at the FAWE grounds. Any animal displaying warts or mites at either initial check in or final weigh-in will not be permitted off the trailer (unless approved by a veterinarian or designee) and will be refused entry into the FAWE. Animals will be inspected prior to unloading. All withdrawal times must be observed for any medication given to a market animal. NO HEALTH CERTIFICATES WILL BE REQUIRED IN 2022 for those in the show.
- 4D. RECORD BOOKS: Each exhibitor must complete a record book on their steer. The record book must be submitted at final weigh-in on March 13, 2022, by 12:00 noon. All exhibitors must use the official FAWE Livestock Record Book. Failure to comply with this rule will result in disqualification. **ALL SIGNATURES MUST BE ORIGINALS.**
- 4E. No steer may be exhibited in competition that cannot be properly managed and led by the exhibitor from the scale to the tie area. A reasonable length of time (approx. 1 hr.) will be given to exhibitor of an unruly animal to demonstrate that the animal can be calmed and safely exhibited. If the animal is dismissed from the showgrounds at this time, the exhibitor is still eligible for the record book contest and must obtain their own health certificate before removal.  
 -If an animal is unmanageable in the show arena, the animal may be tied or dismissed based on the judge's discretion.  
 -No nose tag, nose rings, or other mechanical devices are allowed.
- 4F. Pen spaces will be assigned by the Steer Committee.
- 4G. No exhibitors, nor anyone associated with an exhibitor, shall make abusive comments in any manner to the committee, weigh officials, or judges. To do so may jeopardize exhibitor's future eligibility to show. Questions may be directed to the Committee Chairman or designee.

#### 5. EXHIBIT PERIOD

- 5A. Steers must be cared for from the time of arrival until steers are removed. Steer Exhibitors - Feeding of animals must be completed daily by 9:00 a.m. and again by 9:00p.m. If there is a show going on, the deadline will be an hour after show is completed in the evening.
- Steers are recommended to be exercised daily.
  - There will be no feeding or bathing of animals during any livestock show.
  - Additional care may be provided, at the discretion of the FAWE Livestock Committee.
  - Water containers must be tied in steer pens. Ask livestock committee if you need supplies to tie.
- 5B. For safety reasons, exhibitors will only be allowed to wear close toed shoes such as boots (crops do not fall into this category and are prohibited) around animals. We highly recommend that anyone assisting the exhibitor also wear close toed shoes. The FAWE or FAWE Livestock Committee are not liable for injury to anyone assisting the exhibitor. Please wear the proper shoes when assisting with the animals.

5C. **FEED AND BEDDING:** Bedding will be provided by Management. Feed and water pails must be provided by the exhibitor. Management reserves the right to stipulate the pail type. Materials that may be dangerous, such as fences, metal pitchforks, metal rakes, hay nets, etc. will not be allowed in the **show** area. No flowers or plants will be allowed in the exhibit area, except those provided by management.

-Show boxes or other tack may NOT be placed in the animal pen, wash rack, or show area.

-Each club will be designated a trailer area for supply and equipment storage.

5D. All steers must be secured with halters AND neck ropes simultaneously while tied in the stall.

5E. Unbecoming conduct on the part of an exhibitor, or anyone associated with the exhibitor, will, at the discretion of the Management, result in disqualification of the exhibitor and require immediate removal of the steer and the exhibitor from the FAWE grounds with the loss of awards, premiums, show and/or sale privilege. Exhibitors will not be allowed to stay overnight on the grounds. Profanity in the show ring by the exhibitor will result in a \$250 fine or disqualification. Profanity at any event associated with the Steer Show could result in disqualification.

5F. In the event of an Emergency (defined below) that results in the FAWE Board of Directors necessarily cancelling any show or sale considered a part of the "Livestock Area Events" (defined below), the Exhibitor agrees to hold the FAWE harmless for any financial or other loss by the exhibitor that occurs because of the inability to exhibit and/or market the animal(s) at the FAWE. The preceding statement pertains to the entire period (prior to, during, or after the exhibit days) of the show and/or sale. Financial, or other loss, refers to financial loss due to the inability to market the animal at the FAWE and to loss of premiums and awards due to the inability to exhibit the animal.

"Livestock Area Events" currently include the Swine Show and Sale, the Steer Show and Sale, the POM Show and Sale, Pullet Show and Sale, Poultry Show, Rabbit Show, Open Beef Show, Open Goat Show, Open Horse Show, and events associated with the aforementioned shows and/or sales.

"Emergency" refers to any National, State, or Local occurrence or occurrences that results in the cancellation of Livestock Area Events normally taking place during the FAWE. The cancellation may be dictated by National, State, or Local government agencies with the authority to decree such cancellations to protect the safety of patrons and/or participants or quarantines necessary to protect animal and human health. The Board of Directors of the FAWE also reserves the right to cancel any or all Livestock Area Events that, in the Board's sole discretion, threatens the health and/or safety of the patrons or participant of the event.

5G. **MEDICATIONS:** The administration of medication for bloat, scours, or other conditions shall be done under the direct supervision of a veterinarian or steer committee member; this includes calf calm. The steer committee chairman must be notified that medication is being administered. Unauthorized dispensing of medications is considered unethical and may result in disqualification of the animal and/or exhibitor.

## 6. SHOW, SHOWMANSHIP & SALE

6A. Judging will take place March 14, 2022, beginning at 6:00 pm. The sale of steers will take place March 15, 2022 beginning at 6:00 pm. **No supplies or tack may be removed until March 16, 2022 and must be removed between 1:00 and 3:00 pm.**

6B. Final classes will be determined by weight as necessary to assure manageable numbers in Show Classes. Premiums will be paid in all weight classes. All blue-ribbon class winners will compete for Grand Champion. The steer standing second in the Grand Champion's class will be eligible to compete for Reserve Grand Champion if earning a blue ribbon.

6C. **Exhibitors will be issued 3 arm band passes - one for the exhibitor and two for parent/guardian(s). Additional passes/membership can be purchased up to three weeks prior to the FAWE. Prior to initial entry, the exhibitor must provide the name of the parent, guardian, or approved sibling selected to help. No one other than those approved as a helper, parent/guardian issued an arm band, uniformed law enforcement officers, or FAWE officials, will be allowed in the barn immediately prior to and during the Show and Sale. IT IS THE INTENT OF THE SHOW THAT NO ONE OTHER THAN PARENTS/GUARDIANS, APPROVED SIBLINGS, OR THOSE APPOINTED BY THE FAWE, TO HELP EXHIBITORS CAN HELP TO RESTRAIN AND MANAGE ANIMALS. THE USE OF BLOWER, COMBS, OR BRUSHES MUST BE BY THE EXHIBITORS OR HELPER (PARENT OR DESIGNATED BY THE CHAIRMAN) in the presence of the exhibitor.** The steer committee will provide help for exhibitors whose helpers are unable to assist physically.

6D. OFFICIAL DRESS DURING THE SHOW AND THE SALE IS REQUIRED.

- For 4-H this is: White collared shirt, dark pants (denim is okay), dark boots, and a 4-H clover representation.
- For FFA this is: Official Outside FFA Dress

6E. All Exhibitors and Helpers are banned from using electronic devices in the livestock areas during show times.

Failure to

abide by this rule with result in a fine of \$100 for the exhibitor and removal of the helper for remainder of shows.

All 4-H Leaders and/or FFA advisors can take pictures using electronic devices for record/promotional purposes.

6F. NO CAPS, HATS, GLITTER, OR OTHER PARAPHERNALIA (OTHER THAN OFFICIAL PLACING RIBBONS) WILL BE ALLOWED TO DECORATE STEERS. NO CAPS OR HATS CAN BE WORN BY EXHIBITORS IN THE SHOW RING DURING THE SHOW OR SALE. See 6D for permitted attire.

6G. Exhibitors themselves must exhibit and sell their animal. It is the management's intent to consider waiving this requirement only in the event of a medical emergency.

6H. All who bid and purchase must be pre-registered and must have a buyer number. Buyers are requested to pay the night of the sale. If the buyer requires an invoice to pay, invoices will be mailed no later than 7 days after the sale and payment is expected in 30 days.

6I. Buyers gifts are highly recommended for your projects. These gifts do not have to be expensive it is the thought that counts. *Examples:* Plants, BBQ supplies, Gift Cards, Gift Baskets of anything you feel your buyer will love.

6J. Advise the Prospective Buyer to enter the Expo through Main Gate, where they and one (1), guest will receive FREE admission. Once inside the GATE, the prospective Buyer needs go to the Livestock Office, so they can register themselves, or their company. (*Registration does NOT commit them to purchase an animal*).

6K. ALL ANIMALS SOLD MUST GO TO SLAUGHTER. As a condition of acceptance in the sale, Exhibitor (seller) agrees that all animals in the sale must be sold. No buyer is obligated to buy. There is no guaranteed price per pound.

6L. All Exhibitors will pay their bills relating to their project within 30 days of checks being issued. The FAWE Livestock Committee reserves the right to refuse entry into the show, or subsequent shows, because of any failure of Exhibitor to uphold their financial responsibilities relative to their project. This includes any monies owed to a farmer, rancher, individual, feed mill, or store who supplied/provided an animal, boarding, tack, feed, or hay to an Exhibitor, with the promise of payment to them, once monies were received from the FAWE, and said promise has not yet been fulfilled. The exhibitor will **NOT** be allowed to show any animals at the FAWE until said debts have been paid in full. The debtor must contact the FAWE to advise that said debt has been paid in full.

6M. SHOWMANSHIP participation is mandatory. Club/Chapter/Family entries are eligible for up to two age divisions, once each. Lightweight animals will have a showmanship qualifying class. Those selected by the judge to return will enter their age division.

## 7. POST SALE

7A. Loading of animals after the sale will be done by the Committee members and approved volunteers. No equipment shall be removed until after load-out is completed, March 16, 2022. Exhibitors will be **REQUIRED** to participate in clean-up from 12:00 to 1:00 pm and will be permitted to remove their equipment from 1:00 -3:00 pm. All trash must be removed from tack storage area.

7B. Any livestock exhibitor earning a belt buckle must submit a thank you letter. For steer exhibitors, those are due March 16, 2022, between 1:00 and 3:00 pm at the FAWE Livestock Office (**after clean-up hour!**)

## **INSTRUCTIONS FOR THANK YOU LETTERS TO BUYERS AND BELT BUCKLE SPONSORS:**

**-Letters MUST be handwritten in pen by the exhibitor.**

-Buyer and Belt Buckle Sponsor Addresses will be provided on check-out day March 16, 2022.

-Thank you letters for Buyers and/or Belt Buckles are due on March 16, 2022 from 12:00 – 3:00 pm.

-Place buyer or sponsor letter into a stamped envelope but **DO NOT SEAL ENVELOPE**.

-Turn in your Thank You Letter(s) to the Livestock Committee for review and approval.

- Exhibitors should sign each letter.

**REMINDER:** Exhibitors will be charged \$50 per letter not received or deemed inappropriate for any buyer, add-on, and/or belt buckle. Youth are encouraged to turn letters in early so they can be reviewed and replaced if necessary. All letters should have a greeting/salutation, body paragraph (age appropriate), and a closing/valediction.

7C. Exhibitors Add-on list will be ready for pick-up from your FFA advisor or 4-H Agent no later than March 22, 2022.

-Should the FAWE receive any add-ons for an exhibitor after they have picked up their add-on list, then the exhibitor will be contacted.

-Appropriate and proper (**handwritten in pen by the exhibitor**) thank you letters for all add-ons must be turned in to FAWE, your 4-H Agent, or your FFA Advisor no later than March 29, 2022. All thank-you letters must be in an unsealed, stamped, and addressed envelope.

7D. **CHECKS** will be sent to exhibitors **AFTER** payments for steers and add-ons are received. Any add-ons not received by that date shall be deducted and the responsibility of collection shall be with the exhibitor.

7E. Any exhibitor making \$5,000.00 or more must have a W9; Federal Tax regulation requires the FAWE to obtain Social Security Numbers (SSN) or Taxpayer Identification Number (TIN) from exhibitors to which compensation over \$5,000.00 is paid. SSN or TIN are maintained and used by FAWE for the processing of payments due and are reported to Federal and State agencies on forms required by law. FAWE will not disclose any SSN or TIN without your consent to anyone outside FAWE, except as mandated by law. Failure to provide a SSN or TIN will result in denial of compensation.

7F. Exhibitors agree and consent to the use of pictures, including but not limited to photographs and video, of you and/or your animal in any or all publications, TV, publicity brochure, internet site, or other publicity associated with the FAWE Livestock Show and Sale. Should you have a privacy issue, please let a member of the FAWE Livestock Committee be aware of your situation, along with a letter to the office for documentation.

7G. The FAWE is not responsible for, nor assures the buyers of, carcass quality grade, meat color or palatability. The FAWE is not responsible for spoilage after slaughter. Any carcass that is condemned due to disease damage, drug residue, or injury incurred prior to the loading after the sale is the responsibility of the exhibitor.

7H. Up to six percent (6%) of the actual price will be deducted by the Show to help defray expenses. An additional \$1.00 may be deducted from the exhibitor for the Beef Check-Off as required by law. Financial reports will be made available.

## **8. General Statements**

8A. Final interpretation and administration of these rules will be vested in Show Management and their decision will be final. Any evidence of fraud coming to the attention of Show Management will be prosecuted to the limit of the law.

8B. Any questions or protest concerning compliance with the rules and regulations or the eligibility of an exhibitor or their animal must be submitted in writing to the steer Show Chairman within 24 hours after the discovery of the infraction along with a \$100 fee. The FAWE Steer Committee and/or Management may investigate possible infractions of rules at any time. If your protest is upheld, your fee will be returned. If your protest is unfounded, your fee is forfeited to the FAWE.

8C. The FAWE Management and/or Livestock Committee members reserve the right to visit the steer at the location disclosed as their place of housing with 24-hour notice to exhibitor and parent/guardian. Notice will be in writing to the email address as listed on the entry form.

### **IAFE National Code of Show Ring Ethics**

1. All exhibitors must present, upon request of FAWE or livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or responsible persons shall provide animal health certificates from licensed veterinarians upon request by FAWE or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at FAWE or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of violator drug residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event, which culminates with the animal entering the food chain, shall not be administered drugs other than in accordance with applicable federal, state, and provincial statutes, regulations, and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state, and provincial statutes, regulations and rules affect the animal's performance or appearance at the event. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise. At any time after an animal arrives on the FAWE or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.
5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external application of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
7. Direct criticism or interference with the judge, FAWE or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, FAWE and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the FAWE or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the FAWE or livestock show without recourse against the FAWE or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the FAWE or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.
11. The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.
