PARMA TOWNSHIP BOARD REGULAR MEETING
JULY 8, 2019

The meeting was called to order at 7:00 pm by Chamberlain in the Township Hall, 16407 Comdon Road Albion, MI. The Pledge to the flag followed. Present: Chamberlain, Spangler, Dermyer, Mohney, Engelter, Boehlke, Deputy Caroffino and several observers.

Deputy Caroffino reported on events handled by the Sheriff's department in June.

June 10 Regular Board meeting minutes were entered into the records as presented.

Dermyer gave the treasurer's report. Fund balances as of June 30 are as follows: General \$128,154.52 and Water \$81,570.00. Summer taxes have gone out and payments are coming in.

Engelter gave the fire report. The fire department assets total \$1,171,164.83. Total expenses for the month are \$12,079.73. The biggest expense was for real axle seals and brakes for Rescue 1. There were 65 runs in June, bringing the total for the year to 351. The LUCAS, CPR machine was used on a patient who made it to the hospital with pressure and a pulse. The 800-megahertz radios are now in use. Specs from Spartan for the new truck should be quoted by the end of July.

Chamberlain reported she has had additional communication from Caitlin Bates from the DEQ regarding the reports needed from the water department. Ms. Bates said she will work with our ad hoc committee if needed. Chamberlain will attend the next committee meeting to help with this information so it can be put in writing to the DEQ.

Spangler reported there were 2 zoning, 6 building, 2 mechanical and 6 electrical inspections performed.

There was no Old Business conducted.

NEW BUSINESS:

Chamberlain reported the Jackson County Planning Commission has recommended disapproval the zoning change for parcel 000-06-34-201-002-02 from C2 to I1, JCPC Case # 19-08.
