### FROM THE PRESIDENT'S DESK


Our community continues to be one of the finest places to live in the Marion County

## **MSBU UPDATE**

The Municipal Service Benefits Units (MSBU) can be a rather "sleeper" subject to many of you, but in fact, the program is integral to the safety and well being of all KCPOA residents.

Under the direction of Mr. Moe Turner, Project Manager, Marion County MSTU/Assessments Department, and engineer *extraordinaire*, work began in our community on February 20, 2013. With safety issues a priority, all of the low shoulders along the sides of the road were filled. Then work progressed to the myriad drainage issues. Culvert pipes are being cleaned out to restore water drainage flows. Drainage retention areas and swales are being regraded, again, to restore the drainage systems ahead of the rainy season.

   5809 & 5807 SW 107 St—cleaned driveway pipes
- 5809 SW 108 St—cleaned driveway pipe
- 4926 SW 107 Loop—cleaned cross pipe
- 5062 SW 107 Loop—cleaned cross drain
- SW 111 Ln Rd (in Marco Polo) cleaned cross drain
- Intersection of SW 53 Cir and SW 109 Pl Rd cleaned cross drain
- Intersection of SW 57 Terr Rd and SW 107 St cleaned cross drain
- Between/connecting driveway 5809 & 5807 SW 107 St—cleaned 80 linear ft PVC pipe

SW 109 Loop—cleaned cross drains, driveway pipes

### **LIGHTS UPDATE**

Myself, Marshall Kash, and Len Edwards are working diligently on upgrading the street lights in our community. We started by conducting a "night survey" of approximately 1/2 of KCPOA streets (we will complete the second half in the very near future.)

As we drove around, we identified dark areas that need a street light installed, other areas that are under-illuminated that need brighter street lights, and other areas where the street lights are turned away from the street and need to be re-positioned.

To date, Sumter Electric will be doing the following work:

- Installation of arms with medium cobra lights at pole numbers 69967 at (SW 103 & SW 106); 69984 (SW 103); 70102 (SW 62 Ave); & 70011 (SW 55 Ave.)
- Brighter light at pole 70034 (SW 103 & SW 57 Terr)
- Lights turned to the street and KCPOA assume service at poles 41952 (11540 49 St) and 70441 (5150 107 Loop)

Marshall and Len, thank you very much for all your help and continued assistance with this very important task.

KCPOA has some specific deed restriction concerning commercial vehicles in our neighborhood. Based on the deed restriction, homeowners may not park vehicles that display advertising nor may they have tools or commercial materials that are visible. One way to comply with the deed restrictions is to park the vehicle in the garage. Another way is to use magnetic signs to cover the logos on the vehicle, which are available at several local sign shops. Many commercial vehicles have small, easily covered logos. Magnetic signs are fairly inexpensive and can be cut to fit your needs. The deed may found at under Article II, Section B.13. for future reference. An know you know.
