## TITLE: ACCEPTING APPLICATION FOR ENROLLMENT OF **Tori Burdette**

- WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council (see Article II, Section 1); to include establishing a membership roll (see Section I (j)) determining its own rules of procedure (see Section 1 (j)), and to take such actions as are necessary to carry into effect any of the foregoing power and duties (see Section 1 (k)); and
- WHEREAS, the Articles of Association of Summit Lake Paiute, Nevada (hereinafter Articles of Association) Article III, Section 1 prescribes eligibility requirements to be a member of the Summit Lake Paiute Tribe, and Section 1 © Lineal Descendants of all person in the above categories; and,
- WHEREAS, the Summit Lake Paiute Tribe's Articles of Association grant to the Summit Lake Paiute Council (see Article II, Section 1) certain sovereign powers, including the power, in accordance with the Articles of Association (see Article III) and the Tribe's Enrollment Ordinance (see Article III) to decide who is a member of the Tribe; and,
- WHEREAS, on June 7, 2022, the Enrollment Committee recommended approval of Tori Burdette application for membership; and
- **WHEREAS**, the Tribe's Enrollment Ordinance, Article III, Section 5(a) states a Resolution "shall state: the applicants name, the date of the applicant's birth and that the requirements for membership have been established"; and,
- **WHEREAS**, the Tribe's Enrollment Ordinance, Article III, Section 6©, requires the Council to issue written notice, using Certified Mail with postage fully prepaid and a return receipt required, that the application was approved, providing the Resolution Number and the date of its enactment; and,
- WHEREAS, the Applicant Tori Burdette, has a date of birth of 11/03/2003, and the requirements for membership have been established,

NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council, hereby on the date, June 18, 2022, accepts **Tori Burdette** as a member of the Summit Lake Paiute Tribe and assigns him or her Enrollment Number <u>327</u>.
