## ACKNOWLEDGEMENT OF RISK, WAIVER AND RELEASE

#### I ACKNOWLEDGE AND UNDERSTAND THAT SHOOTING ACTIVITIES ARE INHERENTLY DANGEROUS

And involve both known and unanticipated risks which could result in damage or destruction of property, physical or emotional injury including death of myself or other persons. Said risks also include, but are not limited to: the shooting of myself or others; partial or total loss of eyesight or hearing; inhalation of/contact with lead or other contaminants; being struck by projectiles, flying or falling objects.

I FURTHER ACKNOWLEDGE AND UNDERSTAND that the nature and condition of the RANGE facilities, premises and environment is such that both known and unanticipated hazards exist which create or contribute to both known and unanticipated risks inherent upon entering the RANGE, in using the RANGE facilities and engaging in, or observing any and all activities while on the RANGE. Such hazards include, but are not limited to loose or falling soil/rock; unimproved, unmaintained or uneven terrain; dry/wet walkways, steps and/or roads; domesticated/wild animals; insects; falling tree branches/limbs.
