Speedskates (hockey/figure skates ok for beginners)	Helmet (speedskating, skiing or bicycle)	USS Speedskating Membership
Gloves (leather or cut resistant)	Neck Guard (hockey neck guards work fine)	Middle Atlantic Skating Association (MASA) membership
Long sleeves/Jacket or skinsuit	Long pants/tights/yoga/spandex or skinsuit (no jeans or baggy pants)	Rinks/Club waiver signed
Shin guards (plastic soccer type or integrated cut resistant pads)	Elbow and knee pads recommended by beginners	Protective eyewear strongly recommended

Sundays: Warm-up and off ice conditioning 4:30 pm and on ice instruction 6:30 pm – 7:50 pm*. **IMPORTANT:** Please check the website calendar EVERY WEEK, as times are subject to change. New skaters must let us know in advance if they want to try skating (skating roster is REQUIRED in advance by The Rinks). Learn-to-Skate sessions will be scheduled regularly and advance registration is required.

*Skaters and spectators are required to adhere to any and all COVID-19 protocols as defined by the State of Connecticut, the town of Shelton, The Rinks facility and the Connecticut Speedskating Club. Anyone not adhering to these protocols will be asked to exit the building and membership may be terminated.

RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT


PARTICIPANT – PLEASE READ BEFORE SIGNING (LARGER TYPE COPY available at

In consideration of being allowed to participate in any way in any and all activities, leagues, clinics, events, skating programs at Rinks (“Program”), Participant, acknowledges and agrees that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis, disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. PARTICIPANT KNOWINGLY AND FREELY ASSUMES ALL SUCH RISKS, being both known and unknown of my participation in the Program EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. PARTICIPANT willingly agrees to comply with the stated and customary terms and conditions for participation in the Program, if however, PARTICIPANT observe any unusual significant hazard during my presence or participation, PARTICIPANT will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. PARTICIPANT, for myself and on the behalf of my heirs, assigns, personal representatives, next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS RINKS, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used FROM THE NEGLIGENCE OF THE RELEASES OR OTHERWISE, to the fullest extent permitted by law.

Arbitration: In further consideration of allowing me to participate in the aforementioned, PARTICIPANT hereby agrees to submit to binding arbitration shall be held in Shelton, Connecticut unless otherwise mutually agreed to by all parties. The submission to American Arbitration Association shall be unlimited and the arbitration award may be enforced by any court of competent jurisdiction.
