### Recent Approved Amendment to the SPA

At a recent city of Austin Council meeting the city council approved an amendment to the Strategic Partnership Agreement (SPA) between River Place MUD and the City of Austin. The main purpose for the MUD requested amendment was to ensure that all of the property the MUD's Upper Trail is situated on belongs to the MUD. It was questionable as to whether this was the case or not.

It is very clear now that the property belongs to the MUD. The approval of this change ensures that the trail will remain open and be maintained by the MUD and/or the Limited District. Please remember this is all contingent on the approval to create the Limited District by the residents of River Place MUD. The approval of the Limited District will be presented during the election period May 2018.

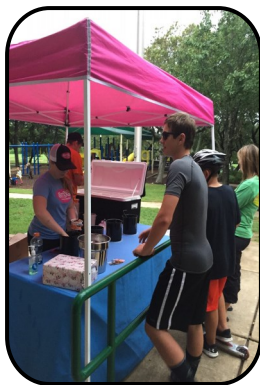
### Board Meetings

### Thank you to all the Volunteers!

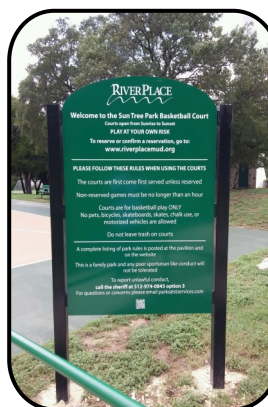
