RULES:

- 1. \$50 or CC on File for Cleaning and Damage Deposit, refunded upon inspection of booth space at close of Flea Market.**
- 2. Flea Market will take place in the Fairgrounds Paved Parking Lot weather permitting; or the Commercial Building. Fairgrounds Maintenance Supervisor will assign Booth Spaces.**
- 3. Set-up Time is Saturday 8:30am – 10:00am; Tear-down Times 4:00pm – 5:00pm**
- 4. There are a limited number of spaces available in the Commercial Building, the first 40 Booths will be reserved; weather permitting more Booths will be rented for the Parking Lot.**
- 5. This is a Trinity County Fair Fundraiser, it is the Renters responsibility to insure all items sold are legal, and any food sold is done so by Trinity County Health Department Standards, it is the Renters responsibility to know the laws and health department regulations.**
- 6. All vehicles are to be parked in the gravel parking lot, prior to start of Flea Market each day. Vehicles needed to support booth, will incur an additional fee, based on space required.**
