Roll call, all in favor, Motion passed.

Motion made by Raymond Guzic, Jr., 2nd Scott Guzic to authorize and adopt Resolution 3-2022 requesting \$300,000.00 for acquisition of a new garbage truck. Roll call, all in favor, Motion passed.

Motion made by Raymond Guzic, Jr., 2nd Scott Guzic to authorize and adopt Resolution 4-2022 requesting \$117,000.00 for acquisition of a new four-wheel drive backhoe. Roll call, all in favor, Motion passed.

Motion made by Raymond Guzic, Jr., 2nd Scott Guzic to authorize and adopt Resolution 5-2022 requesting \$1,000,000.00 for design, permitting and construction of a multi-purpose municipal building. Roll call, all in favor, Motion passed.

Motion made by Raymond Guzic, Jr. 2nd Scott Guzic to authorize and adopt Resolution 6-2022 requesting \$56,100.00 for the preparation of a feasibility study for the September 11th National Memorial Trail and Mainline Canal Greenway. Roll call, all in favor, Motion passed.

Motion made by Scott Guzic 2nd Raymond Guzic, Jr., to retroactively accept the sales agreement between Washington Township and ECS Partnerships dated February 21st, 2022, for \$115,000.00 for the 2022 Local Share Grant from the Commonwealth Financing Authority, no matching funds. Agreement becomes <u>invalid</u> if Washington Township <u>does not receive</u> funding. Roll call, all in favor, Motion passed.

Motion made by Scott Guzic 2nd Raymond Guzic, Jr., to accept the agreement between Washington Township and ECS Partnerships dated March 2nd, 2022, for the Greenway, Trails, and Recreation Grant for 115,000.00 for land acquisition. Agreement becomes <u>invalid</u> if Washington Township <u>does not receive</u> funding from Greenway, Trails, and Recreation Grant, requiring a 15% match. Roll call, all in favor, Motion passed.
