- 1 All classes are combination classes, which means they combine more than one dance Style except basic and intermediate ballet classes. Some classes offer tap and others do not, but they will offer another dance styles other than jazz/funk. The older students will be offered hip-hop/jazz/funk, ballet technique, modern, lyrical, Irish, break dancing, and tap. The younger students will be offered light gymnastics, technique classes in all dance forms, ballet, modern, tap, jazz/funk, lyrical and Irish. The average class size will be about 10-15 students, while some may be slightly smaller or others may be a little larger due to interest. Class length will be 30 or 45 minutes or one hour depending on which class your child is placed in, depending on age and ability level.
- 2. Students will be placed into a class that best meets their needs. This could mean the student starts out in one class and may be moved around to another. Sometimes their needs change and they may need to be moved to another class whether it be up or down. It is the teachers preference as to where the child ends up.
- 3. Parents are not permitted to stay in the class during class without permission from Roxie. There are certain circumstances such as new students and parents days that Roxie may allow parents in the room to watch dance classes. At both studio's there are parent waiting areas and the parents can wait for the dancers there while they are attending classes. NO ONE IS ALLOWED TO WATCH DANCE CLASSES!!
- 4. Attendance will be taken during every dance class and any student missing more than Seven (7) dance classes during the year will have to get Roxie's permission to participate in the recitals and special dances the studio performs. This is going to be enforced because the student needs to be well prepared and know the dance or dances he or she will be performing. Also this needs to be fair to all dancers involved and if there are a few students who cannot attend class regularly and are unprepared than we want to be fair to all students and make sure final performances look nice.
- 5. Students are required to have the following items for dance class: The below shoes can be found at: Walmart, Warner's, and of coure on line at many different options such as : Discount dance supplu, Dance distributors and Amazon.com..
 - A). Black TAP SHOES (low heels) *ONLY if taking tap class
 - B). Black or Pink BALLET SHOES *ages:2-10yrs.
 - C). BlackSlip-On JAZZ SHOES
 - D) DANCE SNEAKERS
 - E). PROPER DANCE ATTIRE: leotard, tights, leggings, stretchy clothing to move in and have something to cover up with if it is cool out

*For ALL <u>NO JEANS OR DRESSES</u>

THIS WILL BE MONITORED AND ENFORCED THIS YEAR SO BE AWARE Your child will not be allowed to participate in dance if he or she wears inappropriate attire. The child will sit and watch class for that session.

6. COSTUME MONEY FOR THE FINAL RECITAL IS DUE IN TWO (2)

INSTALLMENTS. COSTUME MONEY IS ALSO NON-REFUNDABLE!!! This costume money goes towards a dance costume for the final show in June. The costume is a total of \$85.00.00, but you will pay it in two installments to the studio. The first installment for costume money will be \$42.50 and it will be due in October. The second installment will be 42.50 and it will be due in November. <u>ALL COSTUME MONEY MUST BE PAID ON TIME TO ENSURE YOUR</u> <u>CHILD A COSTUME FOR THE FINAL SHOW!!</u>

- 7. There will be a \$30.00 charge for any checks that are returned due to insufficient funds or any other error. Any time this occurs Roxie will no longer accept checks from you for the remainder of the year and you will need to pay by money order/cash.
- 8. Roxie is allowed three sick or personal days per class per year and may take them at any time with notice unless sickness is un-modifiable. Roxie is also allowed a one week personal vacation per year not already included in the calendar year. This has to have ample notice to clients.

9. This is a binding one year agreement to enroll your child in dance and/or gymnastics classes and save a spot at The Roxy Dance Studio for this dance season. This is a 10 month season and you agree to pay for the 10 months of class.
