**Other Business:**

- Richard Dingee along with Chad Falconer came to the meeting to ask if it would be possible, during icy bad weather, if the road commissioner would come and sand at least the entrance of Tenakee Road where the bus turns around. They were both very concerned that the kids might slip and fall, and that the bus would not be able to turn around there. The Road Commissioner told them that he would make sure that it was taken care of during bad icy conditions.
- The Selectboard Chair approved, and signed truck weight permits for, Desrochers Excavating, Inc, and Gould Well Drilling, Inc.
- Sandy handed the Board Contracted Services who receive 1099's, to sign for the upcoming Workman's Comp Audit, scheduled for March-April of this year.
